# Early Career Teacher Service Level Agreement Option 1

This SLA is available for all schools. Schools who choose to deliver the **Core Induction Programme** or provide a **School Led Induction** programme, will need to engage in fidelity checks. **These are undertaken at an additional cost.** (See below)

Our SLA Option 1 package includes the following:

- registration of your ECT with us as the appropriate body
- reporting the status and registering your ECT with the Teaching Regulation Agency
- expert advice and knowledge regarding a school's statutory obligations for all ECT's including formal complaints or challenges
- support offered if your ECT is underperforming or causing concern
- quality assurance and expert review of the statutory assessment of your ECT
- dedicated ECT induction help-desk support to answer queries
- an electronic professional development portfolio which will give induction tutors/subject mentors, headteachers, governors and ECT's key information to support the induction process

#### PLUS...

- Two (half day) training sessions for all induction tutors/subject mentors to support the induction programme, to review key roles, responsibilities and skills required to support your Early Career Teachers and to review the statutory assessment process of your ECT's performance
- A welcome meeting for all appointed Early Career Teachers an opportunity for our ECT's to meet members of the Appropriate Body, to develop networks and ask questions!

# Early Career Teacher Service Level Agreement Option 2

This SLA is for schools who will deliver a **Core Induction Programme based upon the DFE accredited materials** and require fidelity checks to be undertaken by the appropriate body. The SLA will include **all of the elements** included in Option 1 **plus three fidelity checks.** 

#### Cost:

For each ECT - £350 (£175 per year)

PLUS: £900 for the Fidelity Checks

(In addition, if the Appropriate Body considers that the programme is not fully aligned to ECF, then additional checks and support visits may be undertaken and charged at a rate of £585 per day.)



# Early Career Teacher Service Level Agreement Option 3

This SLA is for schools who will be designing and delivering their own two-year **School Led Induction Programme** and require fidelity checks to be undertaken by the appropriate body.

The SLA will include all of the elements included in Option 1 **plus three fidelity checks.** 

#### Cost:

For each ECT - £350 (£175 per year)

PLUS: £1, 350 for the Fidelity Checks (This covers the additional time needed to undertake the checks where schools are not using the DFE accredited materials.)

(If the Appropriate Body considers that the programme is not fully aligned to ECF, then additional checks and support visits may be undertaken and charged at a rate of £585 per day.)

# Early Career Teacher Service Level Agreement Option 4

Our Option 4 package includes all of the elements included in Option 1 PLUS the following:

**Five CPD sessions** to support your Early Career Teacher's Induction programme. These courses have been designed to *compliment* **NOT** *replace* full programme modules or the core programmes offered through the six key funded providers.

These CPD sessions will focus upon the following:

- Behaviour Management
- Meeting the needs of all learners
- How do pupil's learn? Why assessment for learning remains central to the learning process
- Managing workload and well-being
- 'Looking back moving forward'. Preparing for next steps.

These sessions will be delivered via webinar in Year 1.

#### Cost:

For each ECT: £450 (Year 1: £275 – which covers appropriate body services and all training which will be delivered in Year 1, Year 2 £125)

Schools requiring fidelity checks will be charged an additional amount as follows:

\*Core Induction Led Programme – Fidelity checks: Plus £900 per school

\*School Led Induction Programme – Fidelity checks: Plus £1,200 per school

(If the Appropriate Body considers that the programme is not fully aligned to ECF, then additional checks and support visits may be undertaken and charged at a rate of £585 per day.)

#### **Behaviour Management**

Managing behaviour is often seen as one of the biggest challenges for teachers new to the profession.

This session provides an opportunity for you to:

- explore the reasons for poor behaviour
- consider the difference between poor behaviour and additional needs
- examine a range of practical classroom strategies to manage pupils' behaviour

The intended outcomes of the session are for ECT's/ teachers to be able to:

- Recognise different behaviours and identify their cause
- Pre-empt problems before they arise
- Analyse specific triggers and have a range of strategies to avoid them
- Be more confident in their day-to-day management of behaviour issues.

#### How do pupils learn? Why Assessment For Learning remains central to the learning process

This session will revisit the principles of effective assessment for learning and how we can use AFL to support and evaluate pupils' learning. This course will seek to support colleagues in identifying effective strategies to engage pupils in their learning and a range of practical tools we can use to promote pupils' self-evaluation, teacher assessment and the identification of pupils' next steps in learning. We will look at how pupils learn, address some common barriers to learning and progress and consider what is meant by 'impactful feedback'.

#### Meeting the needs of all learners: Identifying barriers, challenges and moving learning forward

**practical teaching and learning strategies** that can be used in the classroom to meet the needs of all learners.

- quickly identify and address pupils' learning needs and barriers to learning to enable them to be successful learners
- create an environment that is safe and effective in supporting pupils' learning
- use a variety of teaching and learning strategies with confidence

#### Managing my workload and well - being - Looking after me!

We will also look at 'mindfulness' and how this can help you to maintain a healthy work life balance and your well-being.

The intended outcomes of this session are as follows:

- To have engaged in a professional conversation about workload, well-being and managing time effectively
- To identify your needs, triggers and evaluate how they impact on your well-being and health
- To consider a number of strategies that can support you in managing your triggers, workload and time management
- To plan your priorities for keeping maintaining your well being
