From: The eastern termination point of the road known as Frogmarsh Lane, Eldersfield at/near grid reference SO79673253 as it approaches Hill Court Farm (Point A on the attached map).  
To Point B at the western start/termination point of bridleway EF-749 at/near grid reference SO80473231 and shown by red dashed line on the map accompanying this application.  
For the avoidance of any doubt as to the precise locations of Points A and B, the new bridleway should provide a continuous link between Frogmarsh Lane and bridleway EF-749 (which continues across Eldersfield Marsh as EF-750 and 751) with no gaps.

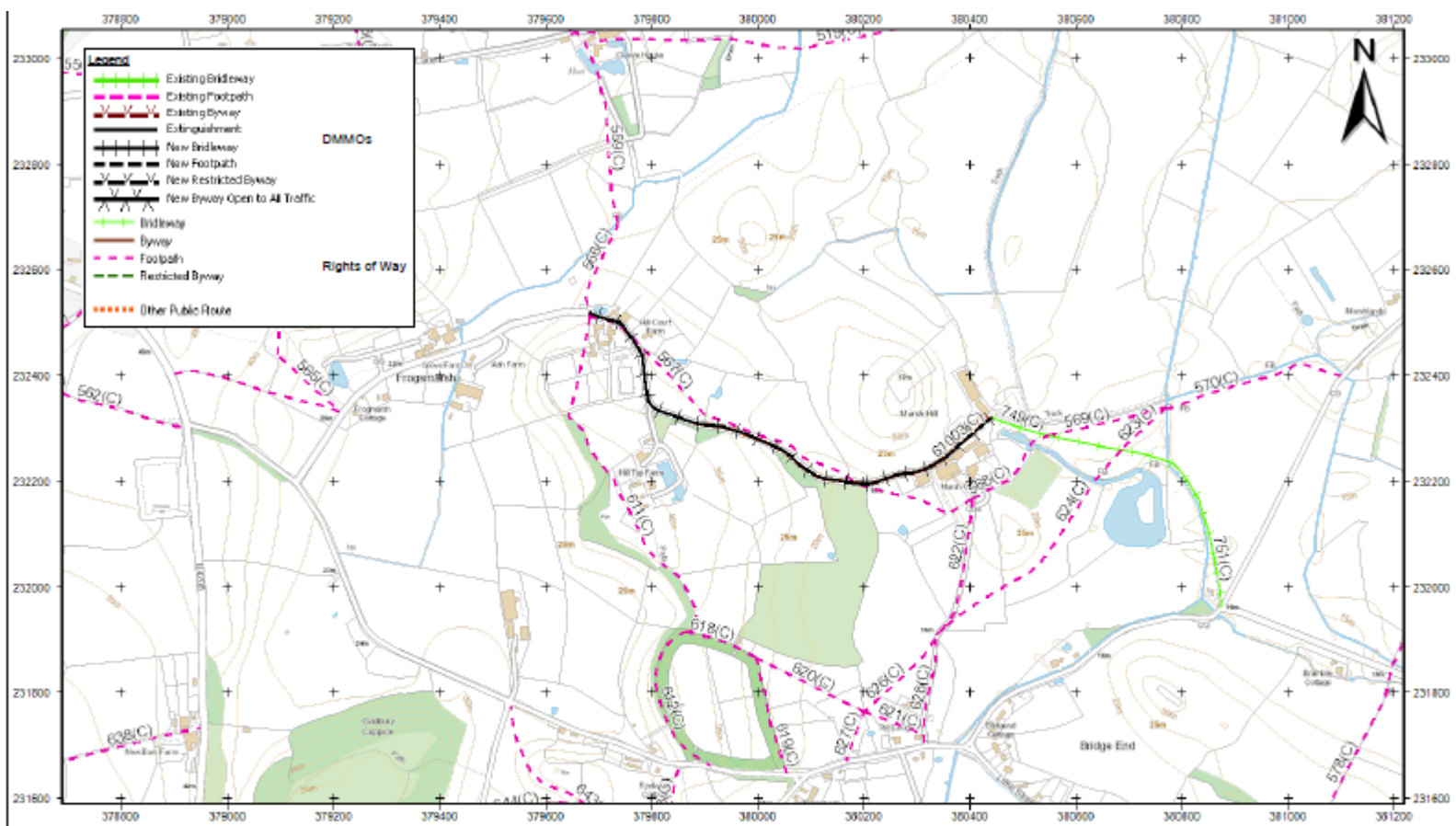
