Background and Purpose

The Worcestershire LNP evolved from the long-standing Worcestershire Partnership Environment Group. One of 48 across England, the LNP was formally recognised by government in September 2012, with the purpose of working at a strategic 'landscape' scale. The LNP brings together a broad range of local organisations, businesses and people to deliver improvements in their local natural environment.

Who we are

The LNP comprises senior representatives from the public, private and third sectors, including professional environmental and land managers. Its broad membership provides the LNP with expertise in developing strategies, planning projects, securing funding and delivering successful outcomes on the ground. The membership includes representatives specialising in biodiversity, geodiversity, landscape and design, planning, flood risk, the historic environment, access and recreation, energy, carbon reduction, forestry, agriculture, transport and economic development.

How we work

The LNP promotes open and honest dialogue within and beyond the environmental sector, making linkages to secure environmental and social gains and supporting economic growth. Partnership working is central to the success of the LNP, the structure of which focuses expertise and resources on our priorities. More detail can be found in the LNP's terms of reference.

Priorities

The LNP's overarching priorities are to improve performance in three thematic areas: biodiversity, water, and climate change. Recognising the priorities' strong inter-dependencies, the LNP is well-placed to make links between partners and working practices to effect positive change. Priorities are reviewed every two years according to policy and evidence (from, among other sources, the Biological Records Centre and Geological Records Centre and from the LNP's *State of the Environment* report), taking account of the LNP's ability, directly and through others, to influence change.

Objectives

Informed by our priorities, the following objectives help focus the LNP's resources:

- Support the Worcestershire LEP's sustainable economic growth ambitions;¹
- Protect and enhance biodiversity, geodiversity, and the built environment;
- Promote effective management of flood risk and natural resources;
- Mitigate and adapt to climate change;
- Support Green Infrastructure and its integration into strategic development sites;
- Promote LNP achievements nationally and collaborate with other LNPs;
- Work with Greater Birmingham & Solihull LEP on LNP issues of mutual interest.

Areas of focus for 2014/16

The main operational areas of focus for 2014/16 are specific projects capable of delivering the greatest gains, and on which the greatest resources will be focussed. These will run alongside our 'standard' business of developing partnerships, raising the environmental profile, and working on short-term, specific initiatives.

➤ **Supporting strategic sites**

As part of the LNP's commitment to maximising the environmental benefits of economic growth in Worcestershire, we will work closely with the WLEP and local authorities to support housing and employment development, with a particular emphasis on the county's economic 'game-changer' sites. The LNP helps to bring together developers and statutory agencies through green infrastructure guidance, leading to a better quality and faster planning application process.

➤ **Delivering landscape-scale green infrastructure in Worcestershire**

The LNP will be identifying one or more specific geographic areas in which to deliver landscape-scale environmental enhancement project. This will allow efforts to be focussed over a strategic area, working with partners, landowners, and businesses to investigate on-the-ground sustainable resource use and explore how to best develop the environmental economy. The project will link directly to the WLEP's Strategic Economic Plan and will include a bid for WLEP and HLF funding to maximise environmental gain.

➤ **Acting on climate change**

Providing a local response to a global challenge, the LNP is co-ordinating Worcestershire's CO₂ reduction programmes to capture the economic and social benefits of minimising emissions and adapting to a changing climate. The LNP will help to shape an overarching Green Deal/Energy Company Obligation programme, leading to direct expenditure in the local economy. In partnership with the county and district councils, LNP members will seek to make best use of EU funds for social housing and other funding to deliver climate change actions. Joint working between the LNP's Climate Change Group and the WLEP will help to ensure climate change remains a cross-cutting driver across Worcestershire.

➤ **Woodland Enterprise Zones**

The LNP will work to extend the opportunity afforded by the Marches Woodland Enterprise Zone to the Wyre Forest, so that the benefits of this innovative project are felt in Worcestershire. A collaborative, cross-border project in partnership with the Worcestershire and Marches LEAs would help to identify and ultimately realise the value of local woodland and timber, bringing forward the potential of the Wyre Forest to contribute to economic growth.

Funding

The LNP is non-statutory and receives no core funding, but has the potential to influence the multi-million pound budgets and resources of its combined membership, and is increasingly the route through which environmental bids for significant European funding are developed and submitted. LNP members commit to providing staff time and in-kind support to the partnership, as necessary.

Reporting mechanisms

Task-and-finish groups take forward each area of focus, with progress reported quarterly at full LNP meetings. The LNP's autonomous status means it does not report directly to any other body, but rather has the freedom to deliver actions and determine its own way of working. The LNP does, however, provide reports and updates to DEFRA as requested, and each member is committed to reporting relevant LNP business to their respective organisation. This is guided by close co-operation with other bodies, especially the WLEP and local authorities, to ensure delivery against the areas of focus is realistic and achievable.

Future Opportunities

As the LNP develops, opportunities will be sought to consolidate its position as Worcestershire's primary environmental voice through influence and exchange with our partners. To maintain and develop positive action, the LNP has set out an indicative two-year work programme at the end of this document which sets out the potential benefits of taking forward a range of actions.
