Private Foresting

Attached is a professional's guide to Private Fostering, I would be grateful if you could bring Private Fostering.

A privately fostered child is a child under 16 (or 18 if disabled) who is being cared for, for 28 days or more, by an adult who is **NOT** their parent, stepparent, grandparent, aunt, uncle, sister, or brother. It's usually a cousin or great aunt, a friend of the family, or someone who has agreed to take care of the child by private arrangement without involving the council.

The parent is still legally responsible for their child. Children Services have a legal duty to ensure children in this situation are safe and well.

Examples of private foster care arrangements:

• There are a number of cases in Worcestershire where a birth parent has left the household through a relationship breakdown or is in prison and the child is left in the care of the birth



- parent's partner. The child will often view this person as a stepparent, however, if the parent and stepparent are not married or in a civil partnership it will fall under Private Fostering Regulations and Children's Services need to be notified.
- Children in this country for education or health care by parents or guardians living overseas. A recent example was a child from Germany whose parents had arranged for a host family to have power of attorney. As the host family is not a close relative this is still private fostering and Children Services needs to be notified.
- Teenagers living with a friend's family as a result of problems at home.
- Children on holiday exchanges that last for more than 28 days.

As a school, you have a legal duty to notify Children's Social Care of Private Fostering arrangements.

Changes to the early years foundation stage (EYFS) framework: January 2024

The Early Years Foundation Stage (EYFS) statutory framework is mandatory for all Early Years settings. It sets the standards that all Early Years providers must meet to ensure that children learn and develop well and are kept healthy and safe.

A <u>full list of changes to the early years foundation stage framework</u> is available for your setting. The changes are mainly regulatory and offer new flexibilities to settings. These changes do not alter the EYFS education reforms that were introduced in 2021.

Promoting and supporting mental health and wellbeing in schools and colleges

Taking a coordinated and evidence-informed approach to mental health in schools and colleges leads to improved pupil and student wellbeing, which, in turn, can improve learning.



The guidance outlining a whole school or college approach describes the areas to consider to enable good mental health and wellbeing practice.

Barnardo's Parental Conflict

What is parental conflict?

There are many forms of conflict in relationships and not all are bad. Harmful parental conflict is a pattern of damaging behaviour that can include:

- 1. Shouting or aggressive arguments.
- 2. Not speaking to each other regularly or for long periods.
- 3. Being disrespectful.
- 4. Letting issues linger rather than sorting things out.

What is most important is how we approach conflict. As adults, we are role models for our children so if we can remain calm and respectful whilst addressing any disagreements, it provides our children with important life skills for future interactions with others.

What is Breast Flattening or Breast Ironing?

"The process during which young pubescent girls' breasts are ironed, massaged, flattened and/or pounded down over a period of time (sometimes years) in order for the breasts to disappear or delay the development of the breasts entirely."
