

S.129A HIGHWAYS ACT 1980

WORCESTERSHIRE COUNTY COUNCIL (LINK FOOTPATH F30673/5, CRABBS CROSS, REDDITCH) GATING ORDER 2012

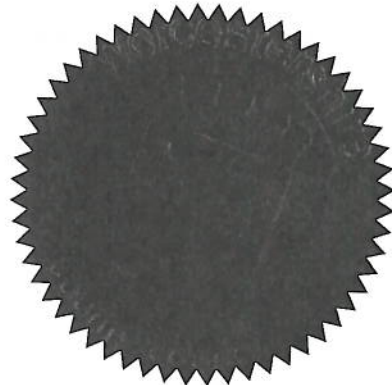
This Order is made by Worcestershire County Council ("the Council") in exercise of its powers under s.129A of the Highways Act 1980 because the Council is satisfied that the premises adjoining or adjacent to the highway Link Footpath F30673/5 between U30202 St Peters Close and U30204 Crabbs Cross Lane in the Borough of Redditch ("the Footpath") shown on the Plan attached to this Order ("the Order Plan") ("the Footpath") are affected by crime and/or anti-social behaviour and the existence of the Footpath is facilitating the persistent commission of criminal offences and/or anti-social behaviour and it is in all the circumstances expedient to make the Order for the purposes of reducing crime and anti-social behaviour.

**By this Order**

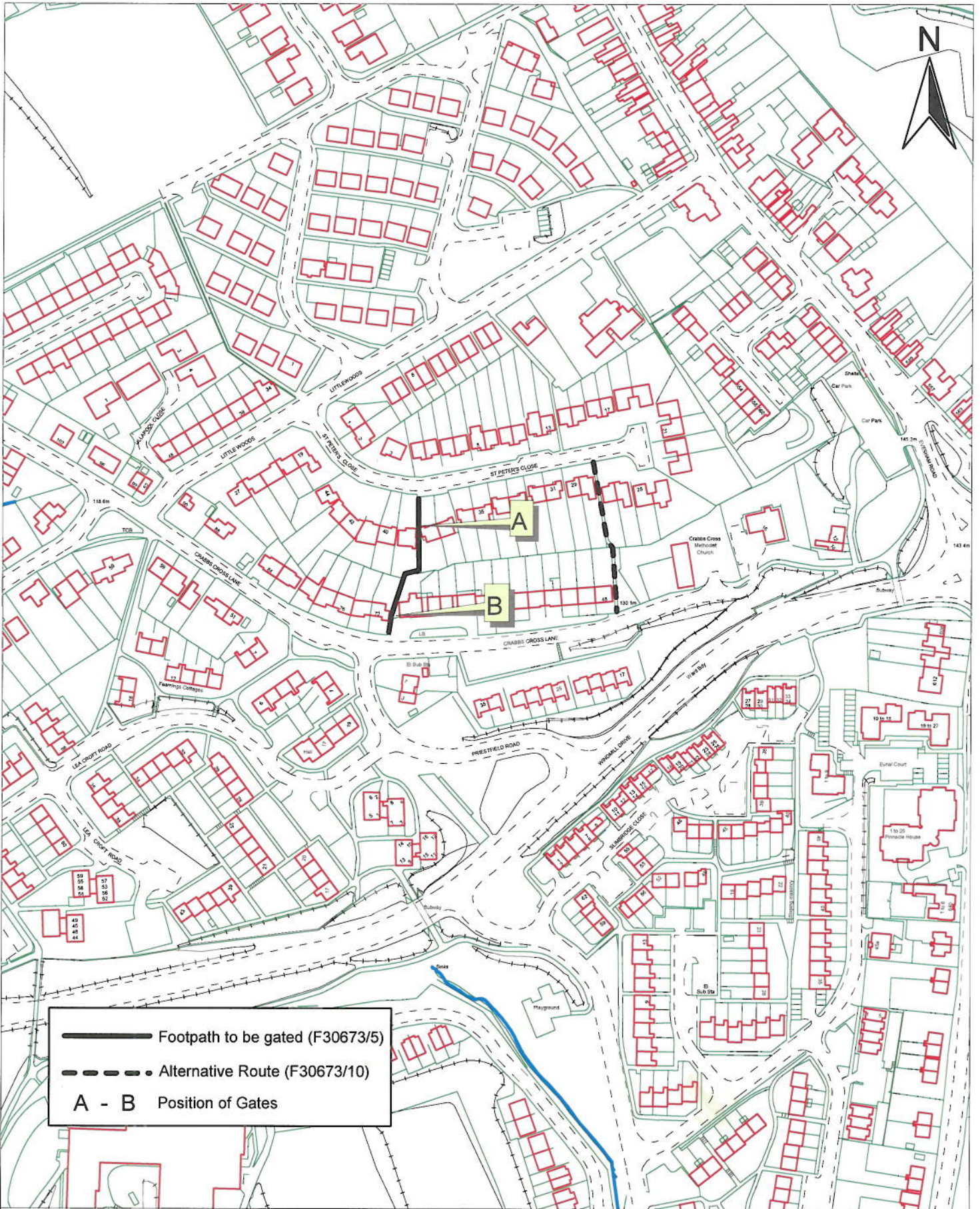
1. The public right of way over the Footpath and shown with a solid black line on the Order Plan shall be restricted between the hours of 18:00hrs Friday to 07:00hrs Saturday and 18:00hrs Saturday to 07:00hrs Sunday.
2. Gates at the points marked A and B on the Order Plan may be installed, operated and maintained for the purpose of enforcing the restrictions provided for in this Order.
3. The alternative route for pedestrians will be via Link Footpath F30673/10 shown with a black dotted line on the Order Plan.
4. Police, Fire Service and Ambulance personnel, statutory undertakers with equipment situated over, along or in the highway, Council officers and other personnel authorised in writing by the Council for the purposes of carrying out works or repairs or maintenance to the highway or adjoining premises shall be exempt from the restrictions imposed by this Order.
5. Any person whose property abuts the public right of way to be gated under the authority of this Order shall be entitled to be provided with a key on request.
6. The person responsible for maintaining the gates is Angie Heighway of Redditch Borough Council, Town Hall, Walter Stranz Square, Redditch, Worcestershire, B98 8AH.
7. This Order shall take effect on the date hereof.

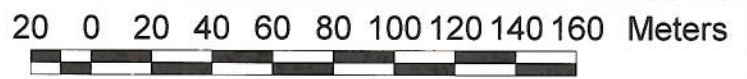
