SEND Notional Funding

SEND Notional Funding is issued to each school, based on an estimated number of pupils with SEND attending the setting. £6,000 per pupil is allocated to fund additional interventions to support children/young people with barriers to their learning. Clarity regarding SEND status, classification and support is essential in ensuring that resources are utilised effectively. Question 30 in section 4 of the e PEP, requests detail on any interventions in place to support a child/young person on the SEND register, or with an EHCP. When completing this question, please give as much detail as possible regarding the intervention/s, the length and duration and whether the intervention is 1:1 or small group. This will enable your Learning Advocate to determine if the PP+, which is CLA specific funding, should be allocated to enhance the learning experience of your CLA.

Recovery Premium

You survey responses informed us that you would like to receive the total grant provided by DfE for Children Looked After Recovery Premium and School Led Tutoring. We have therefore made the:

Recovery Premium

- £145 for each eligible pupil in mainstream education (Yr R-11)
- £290 for each eligible pupil in AP/special academies and special units (Yr R-11)

and

School Led Tutoring

• £39 per CLA (those in years 1-11)

available through the PEP process by the setting of wider educational targets. This funding must be used either in the Spring term or Summer term 2022.

Your VS Learning Advocate will guide you through the process, this will be the same process as attributing PP+ funding to specific targets. In this way every CLA will benefit, and we will all be able to review and monitor the impact.



Interventions and Training

The VS is continuing with the very impactful EP drop-in sessions this term. In addition, the Cracking Stuff professional development will continue, and there will be further support and training opportunities to develop writing in KS2 (particularly Boys' writing), building on the Readiness for Learning and 5Ms professional development that has run previously. We will be sending further communications about these opportunities but in the meantime please feel free to contact your VS Learning Advocate for more detail.

Family Learning

Worcestershire County Council are continuing with their programme of training for parents/carers, to help them support their children/young people with their learning at home.
