

WCF Educational Psychology Drop-in Service for Children Looked After: Consent and Information Form

Worcestershire Children First (WCF) Educational Psychology Service (EPS) is working in collaboration with Worcestershire Virtual school to offer a 'drop-in' consultation service to discuss concerns and needs for Children Looked after. As you are completing this request in relation to a child attending your setting, we want to be sure that you understand who we are and what we do. Consent will then be sought via the allocated social worker unless the child or young person is aged 16 years or above, we will then also secure their consent separately as appropriate for our involvement.

WCF EPS is part of Worcestershire Children First's SEND 0-25 Service. We are all qualified educational psychologists who are registered with the Health Care Professional Council: we also have trainee educational psychologists and assistant psychologists working with us. Our main aim is to facilitate the social, emotional, and educational development of children and young people. We help support families, schools, and other settings with identifying solutions alongside other professionals (including health) who may also be involved.

The 'drop-in' is a consultation service. Consultation is a key means of service delivery for WCF EPS, often defined as a non-directive and collaborative 'problem-solving' discussion.

As part of this work the Virtual School will keep electronic records, which are held securely and confidentially. These records contain personal information, such as name, and date of birth, plus the details of the consultation, including agreed actions. Since we work alongside other professionals who may also be involved, we would want and may also exchange information with these other practitioners. Please note that any, personal data collected will be stored and managed in line with WCF's commitment to the General Data Protection Regulations. Please visit Privacy Statement.

As part of the terms and conditions you will be expected to complete an evaluation 8 weeks post drop-in (unless otherwise stated). This information is fundamental to allow us to monitor impact.
