Elaine went through her report.



Comments/Questions:

Gail asked if people can have a reassessment if things change due to cost of living increases? Can the minimum income guarantee change?

Elaine said this is something that would have to be done by Cabinet Members or someone higher up in the Council. Elaine said if people are really struggling, the Team can look at the Disability Related Expenditure (DRE) but there is no guarantee that this will either decrease or increase contributions.

Nick asked when should people ask for a reassessment. Elaine said if someone is really struggling, they should ask for a DRE review.

Nick asked about energy grants – would this be offset against minimum income guarantee. Elaine said all the extra help income/grants is not included in the financial assessment.

Jenny asked if a Frequently Asked Questions document could be pulled together to help carers find out information they need to help them understand. Elaine said she will ask her Senior if something can be pulled together and included in the SpeakEasy NOW and Worcestershire Association of Carers Newsletters. Elaine said they are hoping to hear something this week after the budget about what is happening.

NFS Herefordshire and Worcestershire Key Worker Project – Caroline Kirby – NHS Herefordshire & Worcestershire Integrated Care Board

Key Worker Project is linked to admission avoidance for people under 25 years old.

Have recruited to the key worker posts and they will sit within the Complex Needs Team and will work across Herefordshire and Worcestershire.

Key themes are around lack of communication across systems; lack of opportunity to speak to the right professionals; lack of information shared around discharge planning; and ensuring the right teams are involved in discharge planning.

Key workers will work closely with CAMHS (Child and Adolescent Mental Health Services) and the Transitions Teams.

Key workers will attend CAMHS (Child and Adolescent Mental Health Services) and Transitions Teams team meetings and will also attend referral meetings.

Key workers will be linked to the Dynamic Support Register so they will only be working with those at risk of admission to hospital or those currently in hospital.

Key workers will link in with SENDIASS (Special Educational Needs and Disability Information, Advice and Support Service) if there are educational needs.

A leaflet is being developed and will be shared at a later stage.


Hear Me Now App – Aimee
