1. Introduction

The Adult Learning Disability Strategy refresh 2019-2022 sets out the vision for partners to work together to improve outcomes for all people with a learning disability in Worcestershire. Worcestershire's Learning Disability Partnership Board is the group of partners which own and oversee the Strategy

2. Aims of the Partnership Board

To oversee the delivery of Worcestershire's Adult Learning Disability Strategy.

The Strategy will achieve its vision by improving the quality of life for people with learning disabilities across 7 Big Aims:

- 5. Staying Safe
- 6. The Right Support for Carers
