ADMISSIONS POLICY FOR STUDENTS STARTING IN SEPTEMBER 2023

Students will be admitted at age 11 to Nunnery Wood High School without reference to ability or aptitude. The number of new student admissions intended for the year commencing September 2023 (our Pupil Admission Number or PAN) will be 300.

All applications for places are coordinated by the Local Authority (LA). Parents or carers apply online at www.worcestershire.gov.uk/admissions and all applications must be submitted by 31st October after which time those naming Nunnery Wood High School will then be sent to us to be prioritised according to our Admissions Criteria. Late applications will be considered after the allocation of the 300 places has been made and offers of these places have been sent out by the LA. Late applications will be considered against the Admissions Criteria (below) regardless of the date when they are received.

The Local Authority will notify all parents/carers of the outcome of their application for a place at Nunnery Wood High School.

Students with a statement of special educational needs or Education Health and Care Plan (EHCP) naming Nunnery Wood will normally be allocated a place after which places will be offered in the following order:

1. All categories of looked after children (LAC) including:
 - Previously looked after children (PLAC)
 - Internationally adopted previously looked after children (IAPLAC)
2. Siblings² of students attending the school and living within the catchment area of the school. In order to qualify for a place on the grounds of a sibling attending the school, the sibling must already be attending the school at the time of application and still be attending at the time of admission. The catchment area map is available on the School website.

In the event of a school catchment area change being approved, students who would still have a sibling connection² at the time of admission and who are living at the same address in the previous catchment area for a school, (but not within the revised catchment area), at the time the change was approved will be considered as living within the catchment area.

3. Children of staff at Nunnery Wood High School, where that member of staff has been employed for two or more years, and/or is recruited to fill a post for which there is a demonstrable skill shortage.
4. Students living within the catchment area of the school. The catchment area map is available on the School website.
5. Students living outside of the catchment area but who would still have a sibling² connection at school at the time of admission. In order to qualify for a place on the grounds of a sibling attending the school, the sibling must already be attending the school at the time of application and still be attending at the time of admission.

6. Students who were attending a feeder primary school (Cherry Orchard, Nunnery Wood, Perry Wood, Red Hill, Stanley Road and Whittington) at the time of application, or who were attending Lyppard Grange Primary School at the time of application.
7. Students who live nearest to the school by the shortest straight line distance³.

Where there are too many applications from within the catchment area, priority will be decided in the order indicated above to all catchment area applicants, i.e. sibling connection, attendance at feeder school then according to distance, each assessed as indicated above.

Tie-breaker

In the case of 2 or more applications that cannot be separated by the oversubscription criteria outlined above, the school will use random allocation as a tie breaker to decide between applicants. This process will be independently verified by the local authority.

NOTES

¹"Looked after" means:

- children currently in the care of or accommodated by a Local Authority under the terms of the Children Act 1989.
- children who were previously accommodated by a Local Authority but immediately after being looked after, became subject to an adoption, residence or special guardianship order.
- children who appear to have been in state care outside of England and ceased to be in state care as a result of being adopted.

²The sibling connection, as well as brother and sister will include half-siblings (that is children who share one birth parent), step siblings and legally adopted children. They must also be living at the same home address. In the event of a multiple birth or a same cohort sibling, all siblings will be offered places even though this might raise the intake number above the PAN. However, in this case the PAN will remain unchanged.

³The measurement will be taken using the GeoCode Points for each property and the Geocode point for the centre of the School. The measurement will be supplied to the School by the Local Authority who use a software package called Arcview GIS to determine distance. Ordnance Survey supply the co-ordinates that are used to plot an address within this system. (In the event of equi-distance applicants, any place will be allocated by random selection (lottery). Someone totally independent of the School will supervise this process)."

Within Worcestershire there is an agreed protocol for students who are deemed to be "hard to place" or who move from one school to another as a "managed move." Nunnery Wood High School has agreed to this protocol.

IN-YEAR TRANSFERS

Applications for places “in year” or outside the normal round of admissions will be dealt with in line with the procedures and criteria outlined above i.e. applicants must fill in a form (CA1) and if the relevant year group(s) is oversubscribed then the Admissions Criteria will be applied.

From 2021, these applications will be co-ordinated on behalf of all schools by School Admissions, on behalf of the Local Authority. The Co-ordinated Scheme can be viewed at the following link:

Nunery Wood High School will notify School Admissions at the Local Authority of its decision, School Admissions will write to parents. Where it is not possible to offer a place, parents will be notified of the right of an appeal.

- 1) If there are insufficient places for all applications received at a time, then priority will be decided in accordance with the published admissions criteria for the school.

ADMISSION OF CHILDREN OUTSIDE THE NORMAL AGE RANGE

Children will be accepted for the academic year group in which they were born. However parents/carers can also request that their child be admitted outside of their normal age group, effectively in the year group below or above their chronological age group. The Headteacher will make the decision based on the circumstances of each case.

WAITING LIST

When all available places have been allocated, we will operate a waiting list. Parents/carers who wish their child to be included on the waiting list must inform us in writing. Any places that become available will be allocated according to the Admissions Criteria above with no account being taken of the length of time on the waiting list or any priority order expressed as part of the main admission round.

The waiting list will be reviewed and revised:

- each time a child is added to, or removed;
- when a child's changed circumstances will affect their priority;
- at the end of each school term;

- if parents/carers with a child on our waiting list should wish to remain on the list for the following term they should notify the Headteacher in writing or submit a new 'In Year' application.

APPEALS

If an application for a place at Nunnery Wood High School is unsuccessful, the parent/carer is entitled to appeal to an independent appeals panel that the school will arrange. An appeal form must be completed and is available via the NWHS website.
