Further to my last email on this, I've had an exchange with Paul Allen at WFDC who is **not content** with the report and has asked for clarity on some specific points. On further reflection I'm supportive of his request and agreed to pass this to yourself so that, if you're willing, you might ask the applicant to consider these questions further. Paul feels the application would benefit from further information on:

- A map showing extent of area surveyed for dormouse
- Name of surveyor and confirmation of their competence (experience and qualifications) to undertake the dormouse survey
- Amounts of nuts surveyed
- Rationale for selecting nut search survey method

Rationale for request: I think the first two points relate to BS42020:2013 clauses 4.3.2, 6.6.1 and 6.7.1. I think the latter two points are in relation to NE's standing advice, which recommends that nut searches are only used: in conjunction with other methods (or to update an older survey), between September and December (I think one of the surveys was in this date range), and searches comprise 5 quadrats of 10mX10m OR checks of 100 nuts for signs of dormice.

I'd welcome any clarification or additional information the applicant can offer on these points. Many thanks Cody.

Thanks very much Steve. This is very helpful in understanding consideration for dormouse in the scheme. No further comments on dormice from me at this stage, thank you. However please do let me know if any further assessment from me of the survey reports submitted would be helpful to facilitate determination.

With regard WWT's comments on understanding sectional profiles of the retained T22 in restored landform: I agree it would be beneficial to see this and I'd welcome a plan showing that section if it could be made available. However, with recent confirmation that dewatering of the root plate isn't considered to pose a risk, and that adequate tree protection measures will be implemented, I'm reassured that T22 is likely to survive operations. Although the two themes are inexorably intwined I think this perhaps becomes more of a landscape than ecological matter as to whether the tree appears appropriately integrated into its final restored landform. As this is outside my expertise I'll defer to my colleagues' consideration on that appropriateness, but I would be interested to see that sectional plan as I think it's likely helpful in better understanding the amended restoration proposal.
