On 10 January 2020 NRS Aggregates Ltd applied to Worcestershire County Council for planning permission for the above proposal. You will recall I consulted you on the above application for planning permission in February 2020.

Following the consideration of the comments that were received on the application and Environmental Statement, the County Council wrote to the applicant in June 2020 requesting further information in respect of the Environmental Statement. On 27 October 2020 the applicant submitted the requested further information, and the County Council are now seeking comments on this further information in relation to a number of matters including: water environment, ecology and biodiversity, landscape, agricultural land classification and soils, cultural heritage, transport movement and access, rights of way, and restoration and aftercare.

The applicant is seeking planning permission to extract approximately 3 million tonnes of sand and gravel over a total of 6 phases. The land would be progressively restored using site derived and imported inert material to agricultural parkland, public access and nature enhancement. The applicant estimates the development would take approximately 11 years to complete.

FURTHER INFORMATION - PROPOSED SAND AND GRAVEL QUARRY WITH PROGRESSIVE RESTORATION USING SITE DERIVED AND IMPORTED INERT MATERIAL TO AGRICULTURAL PARKLAND, PUBLIC ACCESS AND NATURE ENHANCEMENT AT LAND AT LEA CASTLE FARM, WOLVERLEY ROAD, BROADWATERS. KIDDERMINSTER. WORCESTERSHIRE

I refer to your consultation on further information submitted in support of the above application, including the BCL Hydro letter dated 18th September 2020.

We would refer you to comments in our previous letter of 31 March 2020, reference SV/2020/110574/01-L01.

We previously recommended a planning condition be imposed to secure a monitoring scheme for *groundwater*, *surface water - level and quality. We suggested that the* monitoring programme should establish the following parameters:

- 1. Mounding beneath the soakaway ponds is not occurring.
- 2. Water quality in and groundwater around the soakaway ponds is unpolluted.
- 3. Groundwater levels in and around the site are not reducing (as a result of this development/extraction).

We also advised that an Environmental Permit will be required, from us, for the storage, treatment and disposal of inert extractive wastes resulting from the extraction of mineral resources. A further Environmental Permit will be required, should waste be accepted and deposited on site for restoration purposes. No Permit application has been received/twin tracked with the planning application so we cannot give you any certainty on these matters.

To clarify, in relation to some of the latest comments, some groundwater monitoring will be required as part of any Inert Landfill Waste Permit. However, this will be targeted at looking at risks from the waste material and the other recommended planning condition also relates to monitoring the impact of the surface water drainage system and the implications of low permeability material being used as infill. It may be possible for the Environment Agency

two monitoring networks to be combined, as part of the two regulatory regimes, if the monitoring locations are in the right place, to ensure efficiencies.

The applicant should be getting baseline data as part of the Environmental Permit application on quality, levels, gradient etc. An inert site needs at least a year of data to form a representative baseline of the site setting. It is recommended that the applicant considers the following advice, for information relating to inert landfill permit monitoring requirements:

We note the suggestion to change the 'monitoring scheme' condition from 'No development shall take place until.....' to 'prior to the placement of any infill material at the site...'

Maybe it could say prior to any extraction, so a 'scheme' is developed to cover the monitoring for the extraction and before any placement of infill material. This is in consideration of the potential impacts previously discussed, including protection of the surface water ponds.
