

Kepax Bridge Pre-Planning Public Engagement Summary Report

The Kepax Bridge Scheme

The Kepax Bridge Scheme proposes the installation of a cable stayed bridge suitable for use by pedestrians and cyclists between the former landfill site off Hallow Road in St John's on the west side of the River Severn and Gheluvelt Park to the east. The project also includes improving walking and cycling links to and from the proposed bridge location. The scheme is sponsored by Worcestershire County Council and Worcester City Council and aims to improve connectivity for utilitarian journeys to places of work, education and retail areas as well as providing new leisure and recreation opportunities. The Pre-Planning Public Engagement Exercise

The County Council is in the process of preparing a Planning Application for the bridge. There will be a statutory consultation exercise undertaken as part of this process, however, the County Council carried out a Pre-Planning Public Engagement Exercise to help inform the formal application and to gauge public opinion.

The Engagement Exercise formally ran between 17th June and 24th July. It was promoted in print media, on social media and on the County Council website and letters were delivered to residential properties in the immediate vicinity of the proposed bridge location. Participants were provided with information about the proposed scheme and were invited to email their comments to the County Council's Major Projects Team. In addition to this, four public engagement "drop-in" sessions were held; two outside Tesco Express in Martley Road, one on 20th and another on 21st July and two in Gheluvelt Park on 23rd July. Around 160 people attended the events and were encouraged to email their comments to the Major Projects Team.

Summary of responses

275 email responses were received. Of these, 218 expressed support for the scheme, 24 expressed opposition and a further 33 did not expressly support or oppose the proposed scheme but made comments.
