Professional Development Programme - Phase 3

The DfE have provided updated information about Phase 3 of the <u>Professional Development</u> <u>Programme</u> (PDP3). Available to practitioners nationally, PDP3 will be targeted towards reaching disadvantaged children. The Programme is designed to support level 3 qualified practitioners who have not already completed PDP1 or PDP2.

We will be looking for providers to join a cohort in September 2023. Practitioners will have around 7-8 months to complete 3 modules covering:

- Early communication and language
- Early mathematics
- Personal, social and emotional development

Nursery Education Funding

The Provider Portal has been reopened for any funding claims for late starters. If you have any children attending that you have not yet submitted a claim for, you can do so up until Friday 17th February.

If you have any mid-term changes for children already submitted, the Portal will reopen for Adjustment Claims on Monday 27th February 2023.

Closure of the LORT and IPC-COVID-19 services

The locally based COVID-19 response teams will end their work on Friday 31 March at midday. The two teams are the Local Outbreak Response Team and the IPC COVID-19 Team.

SEND Local Offer Survey

The All Age Disability Service have been asked to look at the current webpages of the SEND Local Offer, as this is being updated by Digital Design in order to move it onto a new platform with refreshed graphics and easier navigation.

As you know, the Local Offer provides information about the provision and services that families can expect to be available across education, health and social care for children and young people who have a Special Educational Need (SEN) or are disabled, including those who do not have Education, Health and Care (EHC) plans.

Worcestershire County Council and Worcestershire Children First need to ensure that everything included on the current website makes sense and is helpful and relevant.

As part of this they are keen to look at the way the site is structured to ensure that it is easy for parents, young people and professionals to navigate and find the information they are looking for. They will be looking at the content itself in other activity, but this is about the way the information is organised.

Childminder Mentor Programme

As previously announced, the Childminder Mentor Programme is part of the Covid-19 <u>Early Years</u> <u>Education Recovery Programme</u>. Focused on supporting childminders to address the impact of the Covid-19 pandemic on the youngest and most disadvantaged children, trained early years professionals will provide support which could include:

- Identifying strengths and areas for development
- Improving your confidence in or knowledge of child development
- Implementing the early years foundation stage (EYFS) statutory framework
- Planning an effective curriculum
- Supporting children with special educational needs and disabilities (SEND)
- Supporting children with English as an additional language (EAL)
- Building strong relationships with parents and carers

Following the Supreme Court judgement on <u>Harpur Trust v Brazel</u> regarding the calculation of holiday pay and entitlement of a permanent part-year worker on a zero hours contract, the Government is now consulting to enable them to understand the implications this has on different sectors.

Shaping Us Campaign

The Royal Foundation Centre for Early Childhood's campaign launch preview of their major new '<u>Shaping Us</u>' campaign which aims to increase public understanding of the crucial importance of the first five years of life.

Shaping Us kickstarts with the release of a short film highlighting the incredible rate at which our brain develops before the age of five and how this can shape the rest of our lives. The campaign also highlights how every single person in our society has a role to play in creating change.

Shaping Us is a new long-term campaign from The Royal Foundation Centre for Early Childhood which aims to transform the issue from one of scientific interest, to one of the most strategically important topics of our time. The 90-second claymation film shows how a little girl named Layla develops from pregnancy to age five and how she is shaped by her interactions with the people and environment around her. The short film, which features a track by Lokki entitled "Breathe a Breath of Me", will appear on Piccadilly Lights at Piccadilly Circus and will be screened in cinemas across the UK from Friday.

If you have applied for out of school or non-NEF funding and have had a contract issued, please ensure that this is signed and returned in order for the funding to be released.

Do you have a child with sensory processing difficulties in your setting?

Children with sensory processing difficulties may experience difficulties figuring out what is going on inside and outside of their bodies. They may have an aversion to anything that triggers their senses, such as light, sound, touch, taste, or smell. Children may present with different types of sensory difficulties.

The nervous system processes this information and generates a response or reaction to what is happening around the child. Sensory experiences can help children understand their environments and support them to feel safe and secure.

Worcestershire Children's Physiotherapy and Occupational Therapy Team have set up a support Facebook page to support children with these difficulties. From the page you can access links to useful clips to support all areas of sensory processing difficulties via YouTube.

Edible Messy Play Ideas

Taste-safe playdough

Full fat plain yoghurt Cornflour Mix until no longer sticky

Gingerbread crumble sensory play

2-3 cups of flour
1-2 tsp of cinnamon
½ cup of oil
Blend until it's a crumbly texture to play with

Taste-safe sand

Ground crackers Baby rusks / biscuits More taste safe sand (different colour and smell to above) Ground cereal such as Cheerio's

Chia Slime

¼ cup of chia seeds2 cups of water2-3 drops of food colouring

Jelly shapes in a tray Cooked spaghetti with food colouring Frozen orange segments in a tray Dry food play (cous cous, cereal etc)

Aquafaba

Blend the left over from a can of chickpea with 1-2 tsp of cream of tartar

Taste-safe paint

Greek yoghurt with food colouring

Animateys Pancake Story Workshop

Following the enthusiastic response to our Christmas workshop in December, I am excited to announce that we have now opened up our **Pancake Story Workshop for FREE** for all nurseries, schools and homes in Worcestershire!

This workshop compliments our **Active Storytelling Training**: it gives further ideas for activities and gets the children experiencing a story through multiple senses. The professional version comes with a supporting EYFS learning pack.

If you don't have the facilities to share an active workshop with the children at your setting (ie. large enough screen and sound), please free to share the parents' version with your families - so the children can enjoy it at home.

Grandpa's Birthday Pancake starts with a warmup, followed by a fun story about a pancake. After the story there are games, songs and activities (that you can pick and choose from) - where the children can experience the story physically and vocally.

If you run it all in one go, it takes around 30 minutes. But you can dip in and out as you wish. Make sure to allow space for the children to move around and please be ready to get involved yourself. This is not a passive watching experience - so the adult is key in helping the children get the most from the experience.
