Cooperation with other public bodies: Duty to co-operate

In order to effectively plan for minerals and waste, Worcestershire County Council needs to co-operate with other planning authorities and public bodies at a regional and national level. The Localism Act 2011 formalised and extended this good practice as a requirement in the plan making process known as the 'duty to co-operate' through Section 33A of the Planning and Compulsory Purchase Act 2004.

This duty requires local planning authorities to co-operate with other planning authorities and prescribed bodies¹ on planning issues that cross administrative boundaries to ensure that strategic priorities are properly coordinated and clearly reflected in individual Local Plans.

The details of activities which Worcestershire County Council has undertaken to discharge this duty are set out in the paragraphs below.

Attendance at Officer Groups

At the Worcestershire-wide level these include:

- The Worcestershire Planning Officers Group (WPOG) which brings together senior planning policy officers from the County, City, Borough and District Councils in Worcestershire to deal with a range of planning related issues.
- The Worcestershire Development Management Officers Group (DC Forum) which brings together senior development management officers from the County, City, Borough and District Councils in Worcestershire to focus on development management practice and the interpretation of policy.
- The Worcestershire Green Infrastructure Partnership, which includes statutory
 agencies, local authorities and voluntary sector organisations, to guide the delivery of
 green infrastructure in the county through development, regeneration and
 environmental projects.
- The Minerals and Green Infrastructure Steering Group² which was established to assist with embedding the Green Infrastructure approach in the Minerals Local Plan.
- The Worcestershire Local Nature Partnership (LNP) which comprises senior representatives from the public, private and third sectors, including professional environmental and land managers, providing expertise in developing strategies, planning projects, securing funding and delivering successful outcomes for nature.

At the national and regional level these include:

• The West Midlands Resource Technical Advisory Body (WM RTAB)³ which includes waste planning authorities, waste industry and voluntary and community sector representatives, providing a forum to help waste planning authorities take an overview of strategic waste issues.

A protocol has been agreed to make participants' role clear in this respect (e.g. commitment to actively contribute data on capacity and new permissions, to inform the RTAB AMR, which itself would illuminate regional/cross boundary issues). The Deputy Leader of Worcestershire County Council signed the protocol on the Council's behalf and it was forwarded to the RTAB secretary on 6th November 2013.

- The West Midlands Aggregates Working Party (WM AWP) which is supported by government and includes industry representatives. The group provides expert technical advice, provides scrutiny of and advice on the preparation of local aggregate assessments (LAA), and assesses the overall demand and supply of aggregates in the West Midlands.
- The West Midlands Mineral Planning Authorities Non-Aggregate Minerals
 Discussion Group which meets informally to discuss cross-boundary issues for non-aggregate minerals.

Formal consultation activities on mineral and waste matters

Public consultation was undertaken as part of the preparation of the Minerals Local Plan from 14th July 2015 to 25th September 2015. Late responses were accepted until 27th November 2015 to accommodate late responses from statutory consultees, landowners and the mineral industry.⁴

A consultation newsletter was produced which included:

- A second call for sites providing an opportunity to propose sites for working any type of mineral in Worcestershire
- A call for information on mineral resources and essential infrastructure that supports mineral working which should be safeguarded in the Plan
- An opportunity to comment on the evidence base so far
- Information about the 2013/2014 Annual Monitoring Report.

This was sent to all contacts registered on the Council's planning consultation database for minerals planning policy updates⁵, as well as being advertised by Public Notice and press releases. A document detailing the responses received⁶ was published in February 2016, the sites which were put forward were considered and the results informed the development of the Third Stage Consultation (published in December 2016).

Duty to co-operate activities undertaken with a focus on minerals and waste matters

A schedule of meetings and discussions during the monitoring period outlining key issues and actions is set out in Table 1. The following two strategic issues were pursued during the monitoring period:

Strategic Duty to Co-operate Issue: Provision of Crushed Rock

The main strategic issue of concern in relation to the development of the Minerals Local Plan which was formally raised by Worcestershire County Council and under discussion during April to December 2015 related to the provision of crushed rock in Worcestershire.

Following the meeting of the WM AWP on 27th March 2015 at which a Memo from Worcestershire County Council's Deputy Leader and Cabinet Member for Economy, Skills

and Infrastructure regarding Worcestershire's approach to provision of crushed rock was discussed (see 2014/15 AMR), further discussion and action was undertaken over the course of this monitoring period and into 2016 to agree the approach to be taken forward in the emerging minerals local plan. Full details of these actions are set out in a separate document "Strategic cross boundary issue: Crushed rock supply in Worcestershire - Summary of action undertaken under the duty to cooperate" (September 2016). Strategic Duty to Co-operate Issue: Acceptability of potential mineral sites

Public bodies were asked to comment on whether, considering the issues within their remit, they considered that minerals development on sites which had been submitted for consideration as specific sites in the Minerals Local Plan were likely or unlikely to be acceptable in planning terms.

Comments received informed a "Deliverability Assessment" of the sites published alongside the Third Stage Consultation on the Minerals Local Plan in 2016.

Mineral and waste duty to co-operate relating to other public bodies' activities

Worcestershire County Council engages with other public bodies under the duty to co-operate to ensure strategic issues are fully considered. Most engagement involves issues that can be resolved through the sharing of information and constructive dialogue by letter/email, but some, depending on the issues involved, require ongoing dialogue and meetings. A schedule of meetings and formal consultations during the monitoring period outlining key issues and actions is set out in Table 2.

Worcestershire County Council comments through the Worcestershire "Strategic Planning and Infrastructure Group" (SPAIG) on the minerals and waste implications⁷ of applications made to the City, Borough and District councils for planning permission for strategically significant development in and adjoining the county and on emerging Development Plan Documents. During the monitoring period, Worcestershire County Council made comments on the mineral and waste implications of:

- 30 planning applications
- 1 Neighbourhood Plan area designation
- 9 Neighbourhood Plan consultations
- 4 Local Plan consultations
- 1 Community Infrastructure Levy consultation.
