PUBLIC NOTICE: The Town and Country Planning (Environmental Impact Assessment) Regulations 2017, Regulation 25 Further Information Appeal by NRS Aggregates Ltd (the Appellant) Site Address: **Land at Lea Castle Farm, Wolverley Road, Broadwaters, Kidderminster, Worcestershire.** Appeal Reference: **APP/E1855/W/22/331009.**

NRS Aggregates Ltd have Appealed against the refusal of Planning Application 19/00053/CM by **Worcestershire County Council for Proposed sand and gravel quarry with progressive restoration using site derived and imported inert material to agricultural parkland, public access and nature enhancement.** The application which was submitted to the Council in January 2020 was refused by Worcestershire County Council on 27th May 2022 and an Appeal against the refusal started on 7th November 2022. A Public Inquiry will be opening on 28th February 2023. The Appellant was notified on 13th January 2023 that further information is required in relation to an Environmental Statement which has already been provided. The Further Information is to be submitted on 10th February 2023.
