- The Order shall come into operation on 12 May 2022 and may be cited as Worcestershire County Council (City of Worcester) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2011 (Variation) Order 2022 [Experimental Restriction of Waiting on Comer Road, Worcester].






