Basic Allowance

All Councillors receive a Basic Allowance which is intended to recognise the time devoted by Councillors to their work, including such inevitable calls on their time as meetings (whether Council meetings or meetings with constituents and political group meetings). This allowance is also intended to cover other incidental costs incurred including:-

- Use of home
- Use of telephone (including the cost of mobile phones and other handheld devices of a similar nature)
- Costs associated with member surgeries and other public events (including room hire) which are not facilitated by the County Council.

Special Responsibility Allowance

In addition, a Special Responsibility Allowance is also payable to some members who hold positions of responsibility within the Council. The Chairman and Vice-Chairman of Council receive an allowance to reflect the civic work they undertake. The other positions attracting Special Responsibility Allowances during 2018/19 are listed below. The Allowances scheme structure is shown below:

Travel/Subsistence

Councillors are entitled to receive travel and subsistence allowances where they necessarily incur expenditure on travel and subsistence undertaking official Council business. Subsistence allowances can only be claimed for approved duties out of the county.

Broadband Allowance

Councillors are entitled to assistance with Broadband costs @ £245 pa (payable monthly) subject to proof of payment being provided.
