**Right Support for Carers** 

Sandra and Martin B. fed back the following from the subgroup meeting:

- Specialist dental services some people have been waiting for 3 years
- Carers would like to find best practice examples of providers that are doing a good job of providing weight management advice
- WAC have 2 new people starting at end of March.
- Care Contributions it is important that support plans detail all additional needs that people might have and decisions about funding
- Who to contact if there were issues about housing
- What support is there for elderly carers and getting support packages put in place where appropriate

Rachael Skinner said dental services had been discussed at LeDeR and other forums. NHS Herefordshire & Worcestershire Integrated Care Board are taking on commissioning of dental services from April 2023 and Rachael will find out whether specialist dentistry is also included in this.

Rachael said it is important to recognise when providers do things well. Unfortunately, many examples that come to LeDeR are of where things have not been done well across the system. This is something that LeDeR want to focus on over the next year.

Fran said where we do have examples of good practice, we try to recognise it – one of the providers presented at the online Healthy Bowel Event and shared good practice and useful templates and processes. Another provider has been identified and will be approached to share some good practice relating to end-of-life care.

Adrian said visits have been arranged by Speakeasy to dental services in Hereford and he has contacted 14 high street dentists and has only had one response so far to say they don't have NHS patients only private patients.

Sandra said it is really concerning if you know that someone is not getting appropriate dental health care.

Sandra asked Fran if there was a link to the good practice shared at the online Healthy Bowel Event – Fran said she will check.

Chris and Fran asked for some good quality images to go in the Strategy.

Rachael suggested some information from the Complex Needs Team Key Workers.

Still need a couple of case studies for some themes: Life Changes, Being Safe and Right Support for Carers.

Aiming to get the content finished by end of March 2023 so Chris can put everything into the final design draft.

Good quality images are needed for A Place to Live, A Home; Being Safe and Right Support for Carers. Consent will need to be gained to use the photos in the Strategy.

#### **Comments/Questions:**

Some of the colours do not look good on the big screen (magenta) and it is hard to read – these will need to be changed. Fran said that the colours in the draft are just for the draft version and the final version will look very different.

Martin B asked if the strategy will follow guidelines for people who are visually impaired – colour palettes, links etc. Fran said we will try and follow guidelines as closely as possible. Chris said the plan is to get the design finished as much as we can and we can then focus on the layout.

#### **Celebrating Success**

Fran explained that we will have a regular section on the LDPB agenda called "Celebrating Success" where partners and organisations can showcase and celebrate good practice. Let Fran or Lesley know if you have any items for this section.

On 30<sup>th</sup> January Praxis held its first ever awards ceremony in England. These are case studies of the winners:

Case Study 1:

M has historically suffered from ill health due to complex health needs. Previously they were a frequent inpatient at the local hospital where they were regularly treated for reoccurring chest infections. Their health and wellbeing has greatly improved over the last 12 months. Their mental health has improved significantly. They engage and interact well with all the staff. They are taking part in regular exercise and engaging with activities of their choice. They can regularly be found wandering the grounds of the placement, enjoying the fresh air. They have not had any hospital admissions in 12 months and have remained fit, well and infection free. M expresses themselves well and presents as happy and content. Their improved health and wellbeing has given them more freedom and choice.

Case Study 2:

A came to the placement with a love for music and a whole host of DJ equipment including disco lights, a smoke machine, microphones and endless CDs, not to mention a full set of drums and an electronic keyboard. They became the resident DJ, setting up in the dining room with their equipment, taking to the mic and entertaining fellow residents and staff alike. They take requests and are happy to play anything to suit. The aim has always been to get everyone bopping, dancing and singing away.

Case Study 3:

When C came to live at the placement it was thought they had early onset dementia and that they could no longer live in a supported living setting. Once they had settled in, it was apparent they did not have dementia and they made great progress. It was reported that before moving, they wouldn't socialise with others, ate in their room and liked to wear their pyjamas all day. Over time and with support from staff, they started to do little daily living tasks around the house, giving them a sense of purpose. They also started taking part in activities around the house. One of C's biggest achievements is going out on the bus to the community. It started with short outings but now they go to the theatre, discos, cafes, and meet their parents. Their favourite activity is going for an ice-cream.

#### Giving People with LD a Voice contract – Emma Allen

- WCC Commissioning Team are in the process of recommissioning the contract.

- Emma is meeting with Morag to look at how she and Amanda can meet with Expert Members. Emma will also be contacting Cat at Our Way.

# Issue of people with powered wheelchairs struggling to access public transport - Martin Boniface

- Generally seems to be a disregard from other people on public transport, not making space for people with powered wheelchairs. There isn't enough space on buses for powered wheelchairs and being able to safely get on/off.
- Sam said some of it is to do with bus driver training and gave an example of a bus driver just watching someone in a powered wheelchair struggling to get on the bus – the driver did not know how to activate the ramp.
- Sandra said these issues used to be discussed through the Staying Safe subgroup and fed back to Transport.
- Transport is a cross-cutting theme in the Strategy.
- There is an Active Travel Stakeholder Group being set up by WCC and Fran and Morag are going to sign up.
