## Early Years Bulletin: Worcestershire News and Reminders

## **Nursery Education Funding**

Following the Early Years Funding Consultation that took place over the Summer 2023, the DfE have now published the <u>Government's response</u> to the Consultation, as well as the <u>Early years</u> <u>entitlements: Local Authority funding operational guide 2024 to 2025</u>, which outlines the changes for the Entitlements Expansion in April 2024.

The key decisions made by the DfE as a result of the Consultation include:

- Early Years Pupil Premium (EYPP) will be extended to all eligible children.
- Disability Access Fund (DAF) will also be extended to all eligible children.
- Deprivation Funding can be extended to all eligible age-groups, but is not a mandatory supplement other than for eligible 3- & 4-year-olds.

Indicative Local Authority funding rates have been published alongside the guidance; as previously advised, we will use the results of the Worcestershire Early Years Funding Consultation to determine the recent Worcestershire Nursery Education Funding rates for 2024/25 and are aiming to publish these at the end of January/early February following Cabinet approval.

#### **Out of School Provision**

#### **Early Years Website Updates**

As previously mentioned, we are in the process of updating the <u>Early Years website</u> to improve the guidance and resources available for the sector. We now have a page dedicated to Out of School provision: <u>Playwork and Out of School Settings</u>.

### **Wraparound Expansion Survey**

If you currently offer Wraparound provision, or are interested in opening new places to meet parental demand, we would appreciate you completing a short <u>survey</u> to support our planning for the Wraparound Programme. The survey should only take a couple of minutes to complete.

#### **Out of School Records**

We would also like to update our information about existing out of school provision available within Worcestershire. **If you currently have access to the Online Provider Portal**, we would appreciate you checking the information we have regarding your wraparound provision:

- Log onto the <u>Provider Portal</u>
- Select the appropriate provision type from the drop-down box at the top of the screen (Before School Care and/or After School Care)
- Click on Forms and select Out of School Provision
- Complete the form and submit for each of your out of school provider types

If you offer Out of School provision but do not have a record for Before School Care and/or After School Care available on the Provider Portal, please email <a href="mailto:EYCSystems@worcschildrenfirst.org.uk">EYCSystems@worcschildrenfirst.org.uk</a> with your Provider Name, Ofsted URN and whether you want Before School Care, After School Care or both adding to your record. Once you have received confirmation that this has been done, you will be able to complete the Out of School Provision form with up-to-date details.

**If you no longer offer Out of School provision** but still have the records appearing on your Provider Portal, please email <a href="mailto:EYCSystems@worcschildrenfirst.org.uk">EYCSystems@worcschildrenfirst.org.uk</a> with your Provider Name and Ofsted URN to request the records are deleted.

On behalf of our colleagues at NHS Herefordshire and Worcestershire please find below information to promote the usage of the HANDi app to your parents and carers. They are requesting that settings help the local health systems to promote the paediatric HANDi App which gives parents and carers local advice on what to do when their child is unwell whether that's looking after them at home, taking them to see a GP, using NHS 111, or visiting an urgent care service.

#### HANDi App - Don't let bugs play on your mind

If your child is unwell, use the HANDi App to check their symptoms and get instant, NHS-approved medical advice.

Developed and approved by local Paediatric Consultants, the HANDi App provides expert advice on how best to manage the most common childhood illnesses, including:

- Diarrhoea and vomiting
- High temperature
- 'Chesty baby' illnesses, such as bronchiolitis, asthma and croup
- 'Chesty child' illnesses such as wheezing and asthma
- Abdominal pain
- Common newborn problems.

The app is free, and can be downloaded to any Apple or Android smartphone or tablet.

#### Why use HANDi?

HANDi is designed to help you know what to do when your child is unwell - whether that's looking after them at home, taking them to see a GP, using the NHS 111 service, or visiting an urgent care service.

If your child is unwell, HANDi will ask you questions about your child's condition to help you decide the best course of action - and with all the advice on HANDi developed and approved by local NHS paediatricians and other healthcare professionals, you can rest assured that you're getting the best possible advice.

## Early Years Foundation Stage statutory framework

From Thursday 4<sup>th</sup> January 2024, the Early Years Foundation Stage statutory framework will have two versions, one for childminder and one for group and school-based providers:

- EYFS statutory framework for childminders
- EYFS statutory framework for group and school-based providers

Until 4<sup>th</sup> January 2024, the current EYFS remains in place.

## Early Years qualification requirements and standards

Following the Early Years Foundation Stage Consultation during Summer 2023, updated guidance has been published that comes into effect on **Thursday 4**<sup>th</sup> **January 2024**: <u>Early years qualification</u> <u>requirements and standards</u>. Until 4<sup>th</sup> January, providers must ensure that the <u>current guidance</u> is followed.

## Mental Health for Early Years Children

We all have mental health, just as we all have physical health. In the same way that we can be more or less physically healthy from time to time, we can also be more or less mentally healthy from time to time too.

Help for Early Years Providers has added new <u>information and guidance on supporting babies and young children with their mental health</u>. The guidance:

- Explains how practitioners can support positive mental health in early years children.
- Includes emotional and behavioural support strategies to use in early years settings.
- Links for further reading and resources.

### **Early Years Stronger Practice Hubs**

Early Years Stronger Practice Hubs provide advice, share good practice and offer evidence-based professional development for early years practitioners. Led by the National Children's Bureau (NCB), there are 18 regional Hubs, including the <u>Midlands Stronger Practice Hub: HEART</u>.

The NCB have launched a new <u>Hubs website</u>, bringing together information from across the Hubs, including upcoming events, development programmes and resources.

## Childminder Start-Up Grants

As previously announced, new childminders can apply for a start-up grant to recover the cost of registering as a childminder. Registration must have taken place after 15<sup>th</sup> March 2023 and must be ongoing.

If registration took place between 15<sup>th</sup> March and 31<sup>st</sup> July 2023, the grant application must be received by 31<sup>st</sup> January 2024. For registrations taking place between 1<sup>st</sup> August and 31<sup>st</sup> December 2023, applications must be received by 29<sup>th</sup> February 2024.

Early Help Resources

A <u>recent study</u> produced by Action for Children in partnership with the National Centre for Social Research (NatCen) suggests that one in five children are growing up in material deprivation and 10% of all children are in families with an income below the poverty line.

The findings of the study were echoes of the discussions that took place at the recent Worcestershire Community Hub meeting, where providers described some of the support that is being given to families at your settings.

#### Worcester Child Contact Centre

Worcester Child Contact Centre are the only free supported contact centre in Worcester. They offer a twice a month session for non-resident parents to meet their children. Its aim is to reach families where parental conflict is effecting a parent seeing their children - often due to parents not wishing to see each other.

Their aim is to provide a safe space and help with handover of children so parents can avoid eachother and reduces risks such as the resident parent not knowing where the child is going or when they might be bought back. They are accredited by NACCC (<u>National Association of Child Contact</u> <u>Centres</u>).

Contact sessions run twice a month on a Saturday afternoon and are free to use. Families have to do a self-referral process through NACCC to use the centre.

## Early Years Bulletin: News from the Inclusion Team

## **RETA Funding**

Most children with SEND should have their needs met within the Schools Notional SEN funding and within SEN Support. Children with SEND will need a carefully planned transition in liaison with parent carers, early years provider and school setting to ensure that all information is shared including: needs identified, provision required and what is working well. Some children with SEND may require an enhanced transition package to ensure the next setting is fully aware of needs and is supported in planning on how to meet these.

The new Early Years Inclusion Process has been designed to support the enhanced transition process in several ways:

- Supporting early identification of needs so that targeted provision can be put in place and closely monitored and reviewed over time.
- Additional support from Inclusion Support Services to provide specialist support through the graduated response. If these professionals are involved at point of transition they will be involved in the transition process.
- Ensuring that children who require an EHC needs assessment have this requested prior to transition.

With the above in place, all children's needs should have been identified prior to transition and therefore will have their needs met either within ordinarily available resources, or with additional provision outlined in an EHCP. Therefore, from Summer Term 2024 RETA funding is no longer available to settings as it is not required to support the transition process.

There will be low incident occasions where children have not been known to services prior to starting school, and who present with complex needs. In these cases schools should follow the graduated response utilising their notional SEN budget.
