## Map and plan of the area

Map of B4196 Shrawley and the Experimental Prohibition of Waiting zones implemented by the above order.

### Description of the map

The map shows the Experimental Prohibition of Waiting zones on B4196 **Shrawley**:  
**B4196 Shrawley**- (west side) from its junction with New Inn Lane for a distance of 116m in a northerly direction and 68m in a southerly direction.

**B4196 Shrawley**- (east side) from its junction with the lane to Noutards Green for a distance of 111m in a northerly direction and 85m in a southerly direction.

**New Inn Lane** (south side)- from its junction with B4196 for a distance of 7m in a westerly direction.
