#### **Description of the map**

The map shows the prohibition of waiting zones on Knight Street and Lambert Road, **Worcester**:

**Knight Street: (Both sides)** from its junction with Lambert Road for a distance of 5 metres in both a northerly and southerly direction.

**Lambert Road: (Both sides)** from its junction with Knight Street for a distance of 6 metres in both an easterly and westerly direction.
