

Description of the map

The map shows the prohibition of waiting zones on Ombersley Road and Beckett Road,

Worcester:

Ombersley Road: (West side) from its junction with Beckett Road for a distance of 8 metres in a southerly direction.

Beckett Road: (Both sides) from its junction with Ombersley Road for a distance of 29 metres in a south westerly direction.
