## **Description of the map**

The map shows the prohibition of waiting zones on Ombersley Road and Beckett Road, **Worcester:** 

**Ombersley Road: (West side)** from its junction with Beckett Road for a distance of 8 metres in a southerly direction.

**Beckett Road:** (**Both sides**) from its junction with Ombersley Road for a distance of 29 metres in a south westerly direction.
