## **Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984**

### **WORCESTERSHIRE COUNTY COUNCIL (WYRE FOREST DISTRICT – BEWDLEY AREA) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2007 (VARIATION) ORDER 2024 [PROHIBITION OF WAITING ON SNUFF MILL WALK, BEWDLEY]**

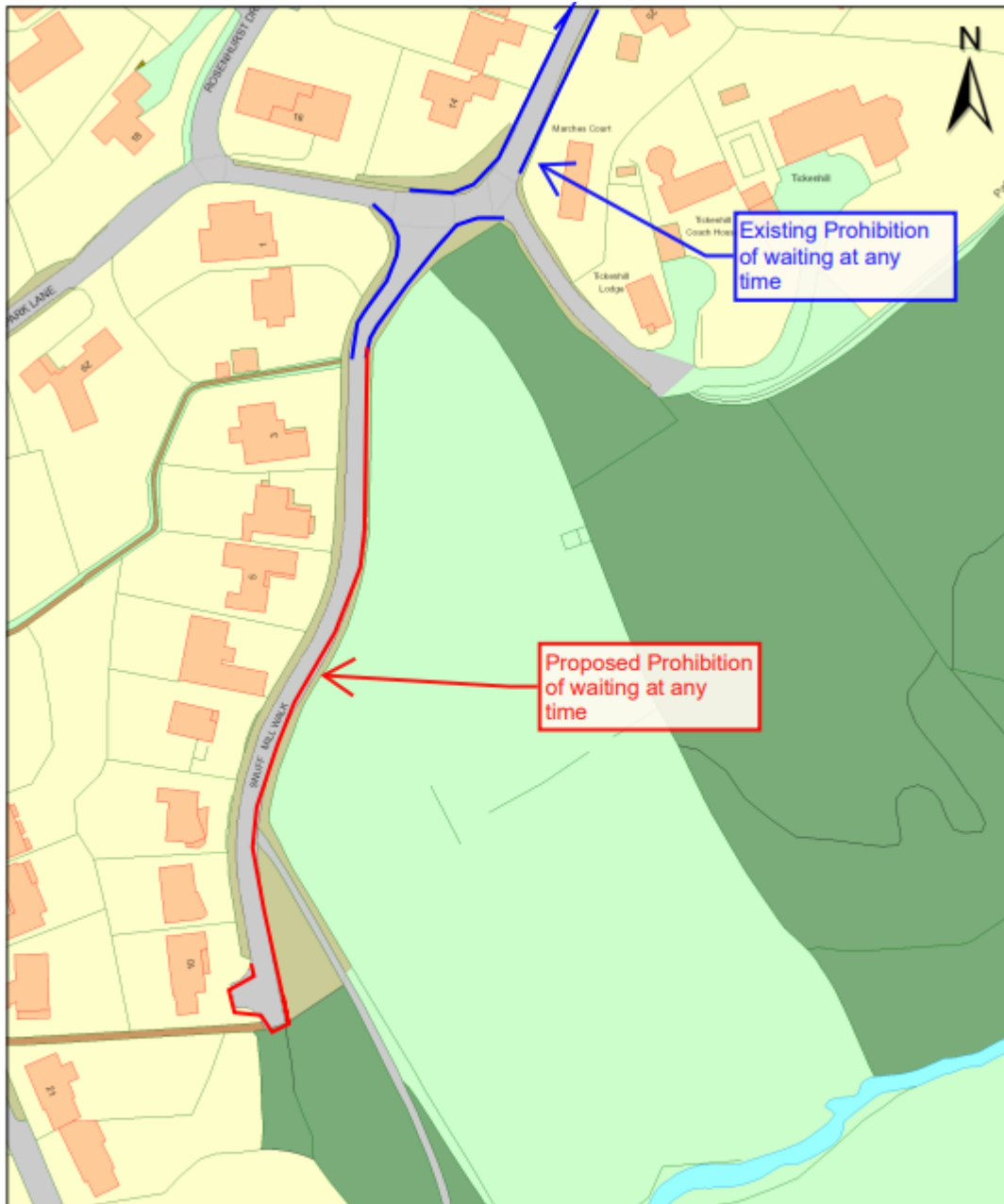


## Map and plan of the area

Map of Snuff Mill Walk, Bewdley and the prohibition of waiting zones implemented by the above order.

### Description of the map

The map shows the prohibition of waiting zones on Snuff Mill Walk, **Bewdley Snuff Mill Walk, Bewdley (East side)** - From a point 43m south of its junction with Park Lane for a distance of 159m in a southerly direction (the entirety of the east side). Additionally, around the cul-de-sac turning area of Snuff Mill Walk (at its southern end) for a distance of 28m in total.
