This Order is made by Worcestershire County Council ('the authority') under Section 118A of the Highways Act 1980 ('the 1980 Act').

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the County of Worcestershire definitive map and statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

The footpaths in the authority's area described below crosses a railway otherwise than by a tunnel or bridge.

It appears to the authority that it is expedient in the interests of the safety of members of the public using, or likely to use, the said footpaths that they should be stopped up.

Bromsgrove District Council has been consulted on the making of the Order as required by Section 120(2) of the 1980 Act.

Worcestershire County Council has required the operator of the railway to enter into an agreement with it to meet any expenses which are incurred in the erection or maintenance of barriers and signs.

THIS ORDER EXTINGUISHES the public right of way over the land situate at Lickey and Tutnall & Cobley shown by a continuous bold line on the map attached to this order and described in the schedule on the date of confirmation of this order and thereupon the County of Worcestershire definitive map and statement shall be modified accordingly.

The entire width and length of the footpath to be extinguished commences at Ordnance Survey Grid Reference (OSGR) SO 9965 7231 (point A on the order plan). It proceeds in a southeasterly direction for 50 metres to meet footpath TC-504 at a point on the parish boundary with Tutnall & Cobley at OSGR SO 9968 7227 (point B on the order plan).

TC-504 (formerly No. 1)

The entire width and length of the footpath to be extinguished commences from footpath LK-524 at a point on the parish boundary with Lickey at OSGR SO 9968 7227 (point B on the order plan). It proceeds in a southeasterly direction for 16 metres to a junction with footpaths TC-505 and TC-503 at OSGR SO 9968 7226 (point C on the order plan).

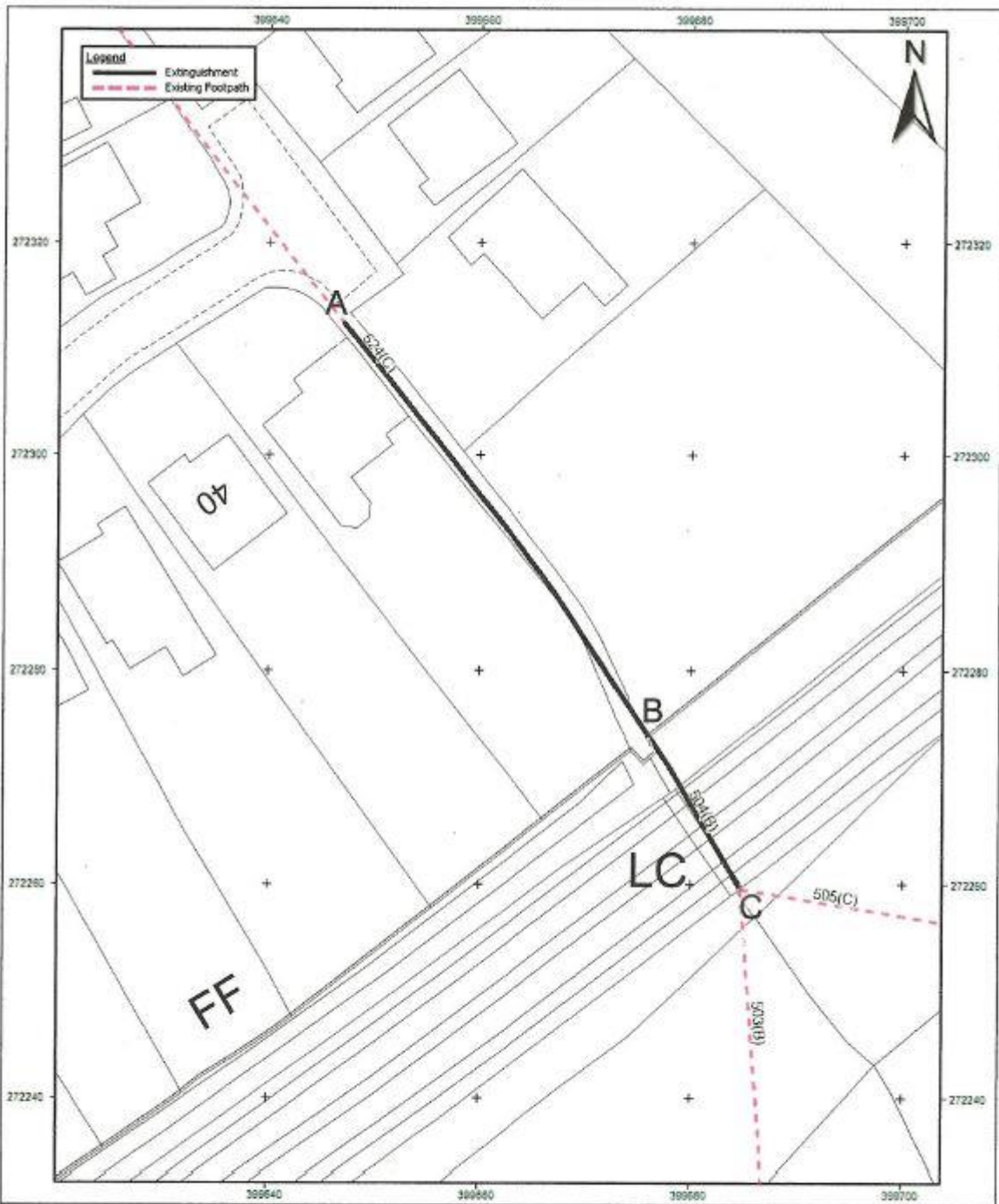
