## **Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984**

### **WORCESTERSHIRE COUNTY COUNCIL (BROMSGROVE DISTRICT) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2013 (VARIATION) ORDER 2024 [EXPERIMENTAL PROHIBITION OF WAITING ON AUSTIN ROAD, BROMSGROVE]**

Worcestershire County Council have made this Order for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising.

Map of Austin Road, Bromsgrove and the Experimental Prohibition of Waiting zone implemented by the above order.

### Description of the map

The map shows the Experimental Prohibition of Waiting zone on Austin Road, **Bromsgrove:-**

#### **Austin Road – Bromsgrove – East Side**

From a point 27m north of its junction with Miller Close for a distance of 12m in a northerly direction.

#### **Austin Road – Bromsgrove – West Side**

From a point 12m north of its junction with Miller Close for a distance of 40m in a northerly direction.
