Map of The Hedgerows, Romsley and the experimental prohibition of waiting zone to be implemented by the above order.

Description of the map

The map shows the experimental prohibition of waiting zone on **The Hedgerows, Romsley:- St Kenelms Road: (Northeast side)** from its junction with The Hedgerows for a distance of 3 metres in a north easterly direction. **(Southwest side)** from its junction with the Hedgerows for a distance of 3 metres in a westerly direction.

The Hedgerows: (Southeast side) from its junction with St Kenelms Road for a distance of 10 metres in a southerly direction. **(Southwest side)** from its junction with St Kenelms Road for a distance of 8 meters in a southerly direction.
