Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (MALVERN HILLS DISTRICT) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2013 (VARIATION) ORDER 2025 [PROHIBITION OF WAITING ON B4211 HANLEY ROAD, UPTON]

Worcestershire County Council propose to make this Order for facilitating the safe passage on the road or any other road of any class of traffic and for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising.

Worcestershire County Council in exercise of their powers under Section 1(1), 2 (1) to (3), 4(2) and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984") and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:

1. The Worcestershire County Council (Malvern Hills District) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2013 is hereby varied by the attachment thereto of the plan attached to this Order (which has the effect of imposing on the road and sides of road identified in the plan attached to this Order a prohibition of waiting in accordance with the provisions of the Consolidation Order).

2. The Order shall come into operation on XXXX 2025 and may be cited as Worcestershire County Council (Malvern Hills District) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2013 (Variation) Order 2025 [Prohibition of Waiting on B4211 Hanley Road, Upton].

Description of the map

The map shows the proposed prohibition of waiting zone on B4211 Hanley Road, **Upton:**
B4211 Hanley Road, Upton- (northeast side) from its junction with the A4104 for a distance of 52m in a north westerly direction and from a point 104m north west of its junction with A4104 for a distance of 120m in a north westerly direction.

Southwest side) from its junction with A4104 for a distance of 53m in a north westerly direction and from a point 96m northwest of its junction with the A4104 for a distance of 125m in a north westerly direction.
