

Map of Humber Road, Worcester and the **Disabled Persons' Parking Space** implemented by the above order.

Description of the map

The map shows the Disabled Persons' Parking Space on Humber Road, **Worcester:**

Humber Road (Southwest side): from a point 52 metres southeast of its junction with Medway Road for a distance of 6.6 metres in an easterly direction.
