Worcestershire County Council in exercise of their powers under Section 84 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as 'the Act of 1984') and all other powers them enabling in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:

- 1. No person shall drive or cause or permit to be driven any motor vehicle at a speed exceeding 30 miles per hour along that road specified in the Schedule to this Order
- 2. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
- 3. This Order may be cited as Worcestershire County Council (Astwood Lane, Feckenham) (30 mph Speed Limit) Order 2025 and shall come into operation on 17 April 2025.


