- 2. No person shall drive or cause to be driven any motor vehicle at a speed exceeding 30 miles per hour along those roads specified in Schedule1 to this Order.
- 3. No person shall drive or cause to be driven any motor vehicle at a speed exceeding 40 miles per hour along those roads specified in Schedule 2 to this Order.
- 4. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
- 5. This Order may be cited as Worcestershire County Council (Various Roads, Catshill) (Restricted Roads and 40 mph Speed Limit) Order 2002 and (Various Roads, Catshill) (Proposal and Revocation) 30 mph and 40 mph Speed Limit) Order 2025 and shall come into operation on 17 April 2025.

- No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
- This Order may be cited as Worcestershire County Council (Various Roads, Catshill) (Restricted Roads and 40 mph Speed Limit) Order 2002 and (Various Roads, Catshill) (Proposal and Revocation) 30 mph and 40 mph Speed Limit) Order 2025 and shall come into operation on 17 April 2025.

- No person shall drive or cause or permit to be driven any motor vehicle at a speed exceeding 40 miles per hour along that part of 84091 (Stourbridge Road) from a point 85 metres north of its junction with UC21000 (Perryfields Road) in a northerly direction to a point 170 metres south of its junction with C2062 (Rocky Lane)
- This Order may be cited as Worcestershire County Council Various Roads Catshill Restricted Roads and 40 MPH Speed Limit Order 2002 and shall come into operation on 28 January 2002.
