Description of the map

The map shows the Prohibition of Waiting zone and the revocation of the 30 minute limited waiting zone on **Back Lane**, **Malvern**:

Back Lane (East side) - from a point 13 metres south of its junction with Edith Walk for a distance of 4.6 metres in a southerly direction and from a point 24 metres south of its junction with Edith Walk for a distance of 11.9 metres.
