## Map and plan of the area

Map of Shrawley Avenue and Rifle Range Road, Kidderminster and the prohibition of waiting zone implemented by the above order.

#### **Description of the map**

The map shows the prohibition of waiting zone on Shrawley Avenue and Rifle Range Road, Kidderminster:

**Rifle Range Road, Kidderminster (southeast side)** - from its junction with Shrawley Avenue for a distance of 10 metres in a south westerly direction and 15 metres in a north easterly direction.

**Shrawley Avenue, Kidderminster (both sides) -** from its junction with Rifle Range Road for a distance of 16 metres in a south easterly direction.
