## **Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984**

### **WORCESTERSHIRE COUNTY COUNCIL (WYRE FOREST DISTRICT – KIDDERMINSTER AREA) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2007 (VARIATION) ORDER 2025 [PROHIBITION OF WAITING ON SHRAWLEY AVENUE AND RIFLE RANGE ROAD, KIDDERMINSTER]**

## Map and plan of the area

Map of Shrawley Avenue and Rifle Range Road, Kidderminster and the prohibition of waiting zone implemented by the above order.

### Description of the map

The map shows the prohibition of waiting zone on Shrawley Avenue and Rifle Range Road, Kidderminster:

**Rifle Range Road, Kidderminster (southeast side)** - from its junction with Shrawley Avenue for a distance of 10 metres in a south westerly direction and 15 metres in a north easterly direction.

**Shrawley Avenue, Kidderminster (both sides)** - from its junction with Rifle Range Road for a distance of 16 metres in a south easterly direction.
