Description of the map

The map shows the Prohibition of Waiting zone on Stockwood Lane, Inkberrow:

<u>Stockwood Lane</u> (South side): From a point 16 metres west of its junction with A422 Stratford Road in a westerly direction to a point 10 metres west of its junction with Windmill Lane.

(North side): From a point 16 metres west of its junction with A422 Stratford Road for 20 metres in a westerly direction.
