Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (MALVERN HILLS DISTRICT) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2013 (VARIATION) ORDER 2025 [PROHIBITION OF WAITING/PROHIBITION OF LOADING (PROPOSAL & REVOCATION) ON COURT ROAD, BARNARDS GREEN, MALVERN]

Worcestershire County Council propose to make this Order for facilitating the safe passage on the road or any other road of any class of traffic and for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising.

It is considered that the Order will contribute to the securing of the expeditious, safe and convenient movement of all traffic (including pedestrians) and will have no adverse effect on other considerations contained in s.122 Road Traffic Regulation Act 1984.

Worcestershire County Council in exercise of their powers under Section 1(1), 2 (1) to (3), 4(2) and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984") and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

1. The Worcestershire County Council (Malvern Hills District) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2013 is hereby varied by the attachment thereto of the plan attached to this Order (which has the effect of imposing on the road and side of road identified in the plan attached to this Order a prohibition of waiting/prohibition of loading at any time and revoking 2 hour limited waiting Mon-Sat 8am-6pm, no return within 2 hours in accordance with the provisions of the Consolidation Order).
2. The Order shall come into operation on **XXXX 2025** and may be cited as Worcestershire County Council (Malvern Hills District) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2013 (Variation) Order 2025 [Prohibition of Waiting/Prohibition of Loading (Proposal & Revocation) on Court Road, Barnards Green, Malvern].

Description of the map

The map shows the proposed Prohibition of Waiting/Prohibition of Loading zone on Court Road, Barnards Green, **Malvern**:

Court Road (southeast side): from a point 58.3 metres southwest of its junction with Barnards Green roundabout for a distance of 16 metres in a south westerly direction.
