# Early Years Bulletin: Worcestershire News and Reminders

### Nursery Education Funding

#### Working Family Funding from September 2025

Applications are now open for families to apply for 30 hours of Working Family funding from September 2025. Families who apply early will need to refresh their details before the end of August so please check Start Dates before offering a funded place.

Children already accessing 15 hours of Working Family funding will be eligible for 30 hours of funding from September, as long as their Eligibility Code is still valid; families will not have to make an extra application, simply refresh their details as required.

#### Reminder: Early Years Pupil Premium

Early Years Pupil Premium (EYPP) is available for all funded children who meet the EYPP criteria, irrelevant of their age. However, to make a successful claim, the 'consent to check EYPP' box must be ticked on the Online Provider Portal. An EYPP check will not be conducted if the EYPP consent box is not ticked and therefore no supplement will be paid, even if the child is eligible.

EYPP is now £1.00 per hour, for a maximum of 15 hours per week.

#### Statutory Guidance Changes

Following the recent changes to the <u>NEF Statutory Guidance</u>, we are continuing to offer 1:1 support sessions to discuss your plans and answer any questions you may have. Additional dates are being offered across the Summer Term: <u>NEF Support Sessions</u>.

## Education Planning Obligations - Consultation on proposed policy changes

Worcestershire County Council is consulting on proposed updates to its Education Planning Obligations Policy, which guides how housing developers contribute to local education infrastructure. New housing developments often lead to increased demand for school and early years places. Where this demand can't be met through existing provision, developers may be required to make a financial contribution towards the cost of increasing local education places. The updated Policy reflects national and local changes, rising demand for specialist SEND provision, and the latest Department for Education guidance. If approved, it will apply to planning applications submitted from 1 September 2025.

# Early Years Bulletin: National News and Reminders

## Free access to 'Maths Champions'

The Education Endowment Foundation (EEF) is offering free access to <u>Maths Champions</u>, a professional development programme that has demonstrated positive impact on children's mathematical attainment.

Delivered by the <u>National Day Nurseries Association</u>, Maths Champions builds the knowledge of nursery practitioners to support children's early mathematical development. A senior member of staff will receive one-to-one support to drive improvement in maths practice across their setting, in addition to bespoke online training and resources.

All PVI, maintained and school-based nursery settings in England with at least six 3&4 year olds attending are eligible to participate. Settings must nominate a Maths Champion and a Deputy Maths Champion who are qualified to Level 3 or above.

The deadline for sign-up is 31<sup>st</sup> May.

#### Early Years Foundation Stage Nutrition Guidance, April 2025

The DfE is committed to ensuring that all children in early years settings have the best possible start in life. As part of this, they have introduced new nutrition guidance in the EYFS statutory framework, which will replace the 'Example menus for early years settings in England' guidance from September 2025.

The new guidance has been developed with nutrition and sector experts. It will help early years providers understand how to meet the existing EYFS requirement: 'Where children are provided with meals, snacks and drinks, these must be healthy, balanced and nutritious.'

From September 2025, providers will be required to have regard to the new nutrition guidance, meaning they must take it into account and should follow it unless there is good reason not to.

#### DBS Check Guidance

Ofsted have updated their guidance on DBS checks for those living or working in a childcare setting to included 'childminder without domestic premises'. The updates also include clarification on the type of DBS checks needed and include links to Ofsted DBS guidance.

## DfE Consultation: Space Requirements in Early Years Childcare Settings

The DfE are consulting on potential options for amending the EYFS indoor space requirements to support childcare provision to expand. The options they are considering are to:

- Include free-flow outdoor space in the EYFS space requirements (without a cap)
- Include free-flow outdoor space in the EYFS space requirements (but with a cap on numbers to prevent overcrowding).

The deadline for responses is Friday 11<sup>th</sup> July 2025.

# Early Years Bulletin: Out of School Provision

## National Wraparound Childcare Programme Support

The National Wraparound Childcare Programme supports the Government's ambition for all parents and carers of primary school-aged children who need term time, childcare during the hours of 8am to 6pm, to be able to access it in their local area by September 2026. Schools are central to the delivery of the programme as they operate at the heart of the community, understand the needs of local families, and are usually the first port of call for parents for wraparound childcare.

The expectation is that most parents can access childcare through provision on a school site (either provided directly by the school or by an external provider). Where there is a strong rationale for this not to be the case, the minimum expectation is for schools to work collaboratively with their local authority to ensure parents are, at a minimum, signposted to appropriate provision.

Childcare Works have produced a series of recording to support schools to understand and the deliver the Wraparound Childcare Programme and is relevant to:

- Maintained school and trust leaders
- School business/finance professionals
- Governing boards in maintained schools
- Academy trust boards and local governing bodies
- Practitioners and teaching staff

## Creating Inclusive Provision Toolkit

The DfE have launched a '<u>Creating Inclusive Provision Toolkit</u>', developed in partnership with Mott MacDonald and Nasen. It is an interactive digital toolkit developed to support schools, private, voluntary and independent (PVI) providers, childminders, and local authorities in creating inclusive wraparound provision that is accessible to families of primary aged children with special educational needs and disabilities. This includes breakfast clubs, after school childcare and holiday provision.

# 7 Minutes of Safeguarding (webcasts)

In recognition of the complexity of safeguarding threats to our children and families we wanted to design an easy way to upskill knowledge for your teams, across many safeguarding themes.

7 Minutes of Safeguarding is simply that, webcasts based on a specific safeguarding topic which give you information, shares research and highlights the relevance to your role and responsibilities. Reflection points allow for further learning and to identify any gaps in knowledge. This short and impactful format makes them ideal as an agenda item for team meetings or could be a great complement to your induction process and on-going commitment to CPD.

There are currently two webcasts in the series for you to access for free. Future webcasts will be added throughout the academic year.


# Sun Safety for Children

Early years practitioners have a duty of care to keep children safe and healthy. Children are cared for throughout the year and every season presents its own challenges: during the summer practitioners must consider sun safety.

There is guidance for schools/early years settings regarding hot weather: Looking after children and those in early years settings before and during hot weather: teachers and other educational professionals

Good practice is to ask parents for a labelled bottle of sun cream early in the year along with a cap or sunhat which can be stored in the provision ready for the warmer weather. Parents must also sign a permission form to give practitioners permission to apply sun cream through the day – this can simply state 'I give permission for my setting/childminder to apply sun cream to my child's skin throughout the day'. You would then note when the cream has been applied, for parents to sign on collection.

It is also good practice to consider the times in the day and length of time children are outdoors during warmer days. It is important to note the UV index alongside the temperature as this tell you how strong the sun is. The Met office forecast will show the UV index.



**UV 1-2** – Low levels. No sun protection needed.

UV 3-7 – Moderate to high levels. Be sun safe and consider protecting your skin.

**UV 8-9+** – Very high levels. Everyone should protect their skin.
