Description of the map

The map shows the Prohibition of Waiting zone on St George's Lane South, **Worcester: St George's Lane South (East side):** from its junction with St George's Lane North for a distance of 42 metres in a southerly direction.

(West side): from its junction with St George's Lane North for a distance of 71 metres in a southerly direction.
