Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (CITY OF WORCESTER) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2011 (VARIATION) ORDER 2025 (PROHIBITION OF WAITING) ON [A38 BATH ROAD, WORCESTER]

Worcestershire County Council have made this Order for facilitating the safe passage on the road or any other road of any class of traffic and for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising.

A38 Bath Road (West side): from a point 99 metres southeast of its junction with Stanley Street for a distance of 12 metres in a south easterly direction.
