### Description of the map

The map shows the Prohibition of Waiting zone on Elm Road and Elmside, **Evesham: Elmside, Evesham (Both sides)**: From its junction with Elm Road for 10 metres in a southerly direction.

**Elm Road, Evesham (South side):** From its junction with Elmside for 10 metres in an easterly direction and for 18 metres in a westerly direction.
