Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (CITY OF WORCESTER) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2011 (VARIATION) ORDER 2025 (PROHIBITION OF WAITING) ON [LANSDOWNE ROAD AND LANSDOWNE CRESCENT, WORCESTER]

Worcestershire County Council have made this Order for facilitating the safe passage on the roads of any class of traffic and for avoiding danger to persons or other traffic using the roads or any other road or for preventing the likelihood of any such danger arising.

It is considered that the Order will contribute to the securing of the expeditious, safe and convenient movement of all traffic (including pedestrians) and will have no adverse effect on other considerations contained in s.122 Road Traffic Regulation Act 1984.

Map of Lansdowne Road & Lansdowne Crescent, Worcester and the Prohibition of Waiting zone implemented by the above order.

Description of the map

The map shows the Prohibition of Waiting zone on Lansdowne Road & Lansdowne Crescent, **Worcester**:

Lansdowne Road (South side): from its junction with Lansdowne Crescent for a distance of 8 metres in a westerly direction and 68 metres in an easterly direction.

Lansdowne Crescent (West side): from its junction with Lansdowne Road for a distance of 11 metres in a southerly direction;

(East side): from its junction with Lansdowne Road for a distance of 5.5 metres in a southerly direction.
