Description of the map

The map shows the **Prohibition of Waiting zone** on Tutors Way, **Kidderminster:**

Tutors Way, Kidderminster (North side) - from a point 4.7 metres west of its junction with Hoo Road for a distance of 11.3 metres in a westerly direction.

(South side) - from a point 5.5 metres west of its junction with Hoo Road for a distance of 11.7 metres in a westerly direction.
