Map of B4035 Main Street, Bretforton and the Prohibition of Waiting zone implemented by the above order.

### Description of the map

The map shows the Prohibition of Waiting zone on B4035 Main Street, **Bretforton**:

**B4035 Main Street, Bretforton (North Side):**

From a point 18m west of its junction with Victoria Gardens for a distance of 18m in an easterly direction.

From a point 42m east of its junction with Victoria Gardens for a distance of 6m in an easterly direction.

**B4035 Main Street, Bretforton (South Side):**

From its junction with Victoria Gardens for a distance of 16m in an easterly direction.
