Map of B4035 Main Street, Bretforton and the Prohibition of Waiting zone implemented by the above order.

Description of the map

The map shows the Prohibition of Waiting zone on B4035 Main Street, **Bretforton:**

B4035 Main Street, Bretforton (North Side):

From a point 18m west of its junction with Victoria Gardens for a distance of 18m in an easterly direction.

From a point 42m east of its junction with Victoria Gardens for a distance of 6m in an easterly direction.

B4035 Main Street, Bretforton (South Side):

From its junction with Victoria Gardens for a distance of 16m in an easterly direction.
