## **Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984**

### **WORCESTERSHIRE COUNTY COUNCIL (WYRE FOREST DISTRICT – KIDDERMINSTER AREA) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2007 (VARIATION) ORDER 2025 [PROHIBITION OF WAITING ON HUMPHRIES DRIVE & MILL LANE, KIDDERMINSTER]**



## Map and plan of the area

Map of Humphries Drive & Mill Lane, Kidderminster and the Prohibition of Waiting zone implemented by the above order.

### Description of the map

The map shows the Prohibition of Waiting zone on Humphries Drive & Mill Lane, **Kidderminster**:

**Humphries Drive, Kidderminster (northeast side)**: from its junction with Mill Lane for a distance of 10m in a south easterly direction;

**Humphries Drive, Kidderminster (southwest side)**: from a point opposite its junction with Mill Lane for a distance of 21m in a south easterly direction and 14.6m in a north westerly direction;

**Mill Lane, Kidderminster (southeast side)**: from its junction with Humphries Drive for a distance of 15.5m in a north easterly direction.
