## **Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984**

### **WORCESTERSHIRE COUNTY COUNCIL (MALVERN HILLS DISTRICT) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2013 (VARIATION) ORDER 2025 [PROHIBITION OF WAITING ON SLING LANE & ALBERT ROAD NORTH, MALVERN]**

Worcestershire County Council have made this Order for facilitating the safe passage on the roads or any other road of any class of traffic and avoiding danger to persons or other traffic using the roads or any other road or for preventing the likelihood of any such danger arising.

## Map and plan of the area

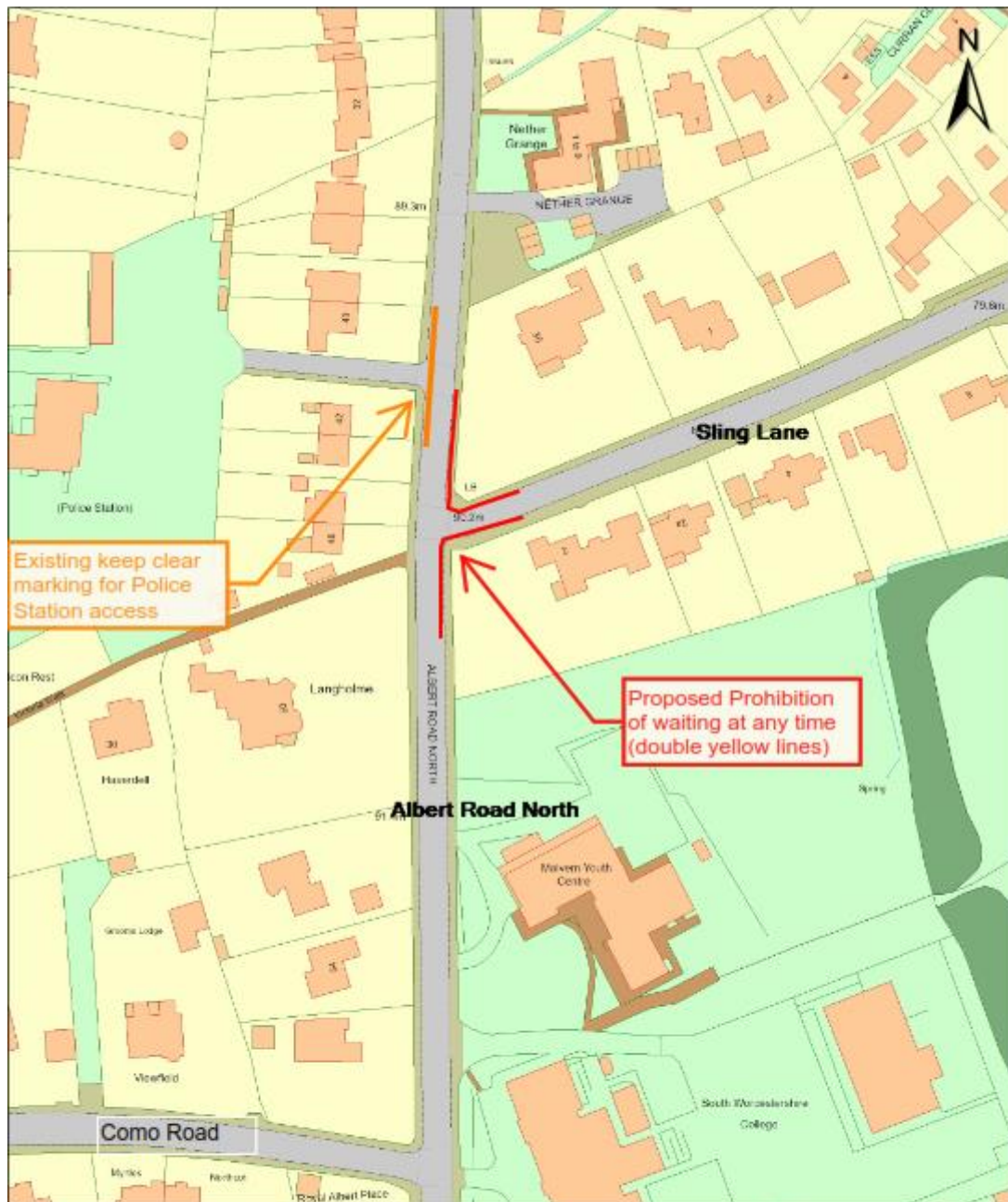
Map of Sling Lane & Albert Road North, Malvern and the Prohibition of Waiting zone implemented by the above order.

### Description of the map

The map shows the Prohibition of Waiting zone on Sling Lane & Albert Road North, **Malvern:**  
**Albert Road North, Malvern (east side):** from its junction with Sling Lane for a distance of 24m in a northerly direction and 20m in a southerly direction.

**Sling Lane (south side):** from its junction with Albert Road North for a distance of 17.5m in an easterly direction.

**Sling Lane (north side):** from its junction with Albert Road North for a distance of 15m in an easterly direction.
