## **Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984**

### **WORCESTERSHIRE COUNTY COUNCIL (DISTRICT OF WYCHAVON – FERNHILL HEATH AREA) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2004 (VARIATION) ORDER 2025 [PROHIBITION OF WAITING ON A38 DROITWICH ROAD AND AGATHA GARDENS, FERNHILL HEATH]**



## Map and plan of the area

Map of A38 Droitwich Road and Agatha Gardens, Fernhill Heath and the Prohibition of Waiting zone implemented by the above order.

### Description of the map

The map shows the Prohibition of Waiting zone on A38 Droitwich Road and Agatha Gardens, **Fernhill Heath:**

**A38 Droitwich Road (Southeast side):** from its junction with Agatha Gardens for a distance of 9 metres in a north easterly direction and 10 metres in a south westerly direction.

**Agatha Gardens (Both sides):** from its junction with A38 Droitwich Road for a distance of 13 metres in a south easterly direction.
