Description of the map

The map shows the Prohibition of Waiting zone on A38 Droitwich Road and Agatha Gardens, **Fernhill Heath:**

A38 Droitwich Road (Southeast side): from its junction with Agatha Gardens for a distance of 9 metres in a north easterly direction and 10 metres in a south westerly direction.

Agatha Gardens (Both sides): from its junction with A38 Droitwich Road for a distance of 13 metres in a south easterly direction.
