Map of Habberley Road, St Johns Avenue and Briars Gardens, Kidderminster and the Prohibition of Waiting zone implemented by the above order.

Description of the map

The map shows the Prohibition of Waiting zone on Habberley Road, St Johns Avenue and Briars Gardens, **Kidderminster:**

Habberley Road (south side): from its junction with St Johns Avenue for a distance 11 metres in a north westerly direction and 12 metres in an easterly direction.

Habberley Road (North side): from its junction with Briars Gardens (private road) for a distance 9 metres in a north westerly direction and 7 metres in an easterly direction.

Briars Gardens (private road) (both side): from its junction with Habberley Road for a distance of 7 metres in a southerly direction.

St Johns Avenue (west side): from its junction with Habberley Road for a distance 17 metres in a southerly direction.

St Johns Avenue (east side): from its junction with Habberley Road for a distance 14 metres in a southerly direction.
